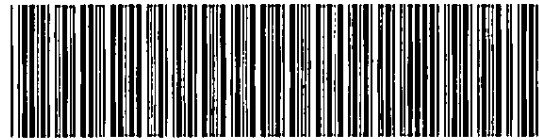

The undersigned incorporator hereby files these Articles of Incorporation for a non-profit company, as follows:

**ARTICLE I**

Name of Entity: The name of this entity will be THE MIRACLE HOME - FLORIDA, INC.

**ARTICLE II**

Effective Date of Incorporation: The effective date of this incorporation shall be the date of filing in the office of the Florida Department of State, Division of Corporations.

**ARTICLE III**

Existence of Entity: The entity will have perpetual existence.

**ARTICLE IV**

Manner in which Directors are Elected: Directors shall be elected as provided for in the Bylaws.

**ARTICLE V**

Principal Place of Business: The principal place of business of the entity is 1615 Village Square Blvd., Suite #7, Tallahassee, FL 32309.

## **ARTICLE VII**

**Incorporator:** The Incorporator is Claire A. Duchemin, 1615 Village Square Blvd., Suite #7, Tallahassee, FL 32309.

## **ARTICLE VIII**

**Corporate Purposes:** The purposes of the entity are:

(A) The corporation is organized exclusively for charitable purposes, including providing housing, food, and monetary assistance to children who are orphans, who have been placed for adoption, or who have been removed from their parents. The corporation may also provide funds to other charitable entities who qualify as exempt under section 501(c)(3) of the Internal Revenue Code or the appropriate section of any future tax code. The corporation may also serve as a third party adoption agent for orphans.

(B) No part of the net earnings of the corporation shall inure to the benefit of or be distributable to any Director, Officer, or member of the corporation, or any other private individual (except that reasonable compensation may be paid for services rendered to or for the corporation, and reasonable expenses may be paid thereto, affecting one or more of the corporation's purposes), and no Director or Officer of the corporation, or any private individual shall be entitled to share in the distributions of any of the corporate assets upon dissolution of the corporation. No substantial part of the activities of the corporation shall include carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall neither participate nor intervene (including the publication or distribution of statements) in any political campaign on behalf of any candidate for public office, at any time.

(C) The entity shall NOT be used for any purposes which would adversely impact its status as a section 501(c)(3) entity under the applicable provisions of the Internal Revenue Code.

## **ARTICLE IX**

**Initial Officers and Directors:** The name and address of the initial Director and President of the entity is Claire A. Duchemin, 1615 Village Square Blvd., Tallahassee, FL 32309 (D). The name and address of a second initial Director and the Vice-President and Treasurer is Denise Gillespie, 1608 Hibiscus Ave., Winter Park, FL 32789 (D). The third initial Director is John A. Rooks, II, 4431 Sierra Court, Tallahassee, FL 32309 (D).

## **ARTICLE X**


**Dissolution of Entity:** Upon the dissolution of this entity, its assets shall be distributed to a like entity for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government or to a state or local government for a public purpose consistent with the purposes for which the corporation is being established. Any assets not so disposed of shall be disposed of by the Circuit Court of the Second Judicial Circuit in and for Leon County, Florida, exclusively for such purposes or to such organizations as the Court shall determine are organized and operated exclusively for the same purposes as this corporation.


