ARTICLES OF INCORPORATION OF Arclight Foundation, Inc. A FLORIDA NONPROFIT CORPORATION

In Compliance with Chapter 617, F.S., (Not for Profit)

<u>ARTICLE I NAME</u>

The name of the corporation shall be: Arclight Foundation, Inc.

ARTICLE II PRINCIPAL OFFICE
