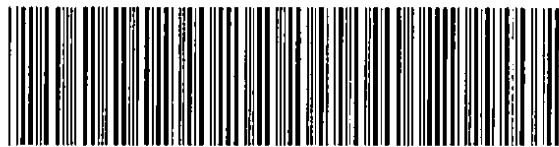

Article I: The name of the corporation shall be: The Light Preparatory Academy, Inc.

Article III: 1. The Corporation is not-for-profit and is organized and shall be operated exclusively for educational purposes as described in Section 501(c)(3) of the Internal Revenue or corresponding section of any future tax code.

2. The corporation admits students of any race, color, national, and ethnic origin to all rights, priveleges, programs, and activities generally or made available to students at the school. It does not discriminate on the basis of color, race, national

and ethnic origin in administration of its educational policies, admissions policies, scholarship, and loan programs, and athletic and other school-administered programs.

3. Upon the dissolution of the Corporation or the winding up of its affairs, the assets of the Corporation remaining after the payment of all costs and expenses of such dissolution shall be distributed exclusively to charitable, religious, scientific, literary, athletic or educational organizations (i) as selected by the last serving Board of Directors of the Corporation (ii) or as otherwise required by applicable law, which would then qualify under the provisions of Section 501(c)(3) or the Code.
