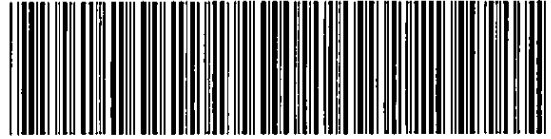

The Articles of Incorporation of  
Great Mind, Great Future Summer Camp, Inc.

( A Florida Nonprofit Corporation)  
In Compliance with Chapter 617, F.S., Non Profit)

The undersigned, for the purpose of forming a nonprofit corporation under the laws of the State of Florida, do hereby adopt the following articles of incorporation.

**ARTICLE I.**

**Name**

The name of this corporation shall be Great Mind, Great Future Summer Camp, Inc. (hereinafter called the "Corporation").

**ARTICLE II.**

**PRINCIPAL OFFICE AND MAILING ADDRESS**

The principal office and mailing address of the Corporation is 2892 Tennis Club Dr. #103, West Palm Beach, Fla 33417

**ARTICLE III.**

**PURPOSE**

This Corporation is a non-profit corporation, summer camp for children to focus on learning, in Section 501 © (3) of the Internal Revenue Code 1986 and the purpose of engaging in any lawful act or activity not for pecuniary profit for which non-profit corporation may be organized, so far as or may be permitted by the laws of the State of Florida and Section 501 © (3) of the Internal Revenue Code on 1986 as amended. Also there will be several programs organized to operate through Great Mind, Great Future Summer Camp, Mentoring, Tutoring and literacy skills. These programs will serve as an enrichment program that will serve the children and the community. Helping students build the skills needed to succeed.

**ARTICLE IV.**

**MEMBERSHIP**

Any person, relative, corporation, partnership, association or organization, who is interested in the purpose of the Corporation, who is capable of contributing to the achievement of the purpose and the effective operation of the Corporation, and who complies with the requirements established from time to time by the Bylaws, shall be eligible for membership.

**ARTICLE V.**

**INITIAL REGISTERED OFFICE AND AGENT**

**ARTICLE VI.**

**ARTICLE VIII.  
DISSOLUTION**

Upon the dissolution or winding up of this Corporation its assets remaining after payment, or provision for payment, of all debts and liabilities of the Corporation, shall be distributed to a non-profit fund, foundation, or corporation which is organized and operated exclusively for charitable purpose and which has established its tax exempt status under Section 501 © (3) of the Internal Revenue Code 1986, as amended, or corresponding provisions of any subsequent federal tax laws.

**ARTICLE IX.  
LIMITATIONS**

No part of the net earnings of the corporation shall inure to the benefit of, or be distributed to its directors, officers, member or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to the activities of the Corporation shall be carrying on of propaganda, or otherwise attempting to influence legislation ( except as otherwise provided in subsection (h) of Section 501 of the Internal Revenue Code of 1986, as amended), and the Corporation shall not participate or intervene in (including the publishing or distribution of statement) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these Articles, the Corporation shall not carry on any activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501 © (3) of the Internal Revenue Code of 1986, as amended (or the corresponding provision of any future United States Internal Revenue law).
