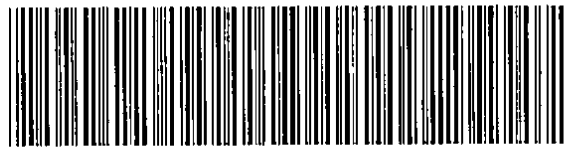



Article I – Name

The name of the not for profit corporation is Space Coast Birding and Wildlife Association, Inc.

Article II - Effective Date

Article VII – Purposes

The not for profit corporation is organized and will be operated exclusively for general and educational purposes as set forth in Section 501(c)(3) of the Internal Revenue Code, including, for these purposes, the making of distributions to organizations, that qualify as exempt organizations under Section 501(c)(3) of the Code. **Articles of Incorporation
Space Coast Birding and Wildlife Association, Inc.
A Not for Profit Corporation**

Space Coast Birding and Wildlife Association, Inc. is a not for profit community organization whose sole purpose is to encourage awareness, appreciation, education, preservation and protection of the diversity of birds, wildlife and habitats the Space Coast has to offer.

Article VIII - Dedication of Assets and Dissolution

The not for profit corporation's assets are irrevocably dedicated to its charitable benefit purposes. Upon dissolution of this not for profit corporation, all properties and assets remaining after payment, or provision for payment, of all debts and liabilities of the not for profit corporation, including disposition of assets, shall be distributed to a nonprofit fund, foundation, or corporation that is organized exclusively for charitable purposes, pursuant to Section 501(c)(3) of the Internal Revenue Code.

If any assets not distributed as provided in the preceding paragraph, the court of appropriate jurisdiction of the county in which the principal office of the non for profit corporation is then located, will dispose of those assets exclusively, for charitable and educational purposes or to one or more organizations that are, at that time, qualified as exempt organizations under Section 501(c)(3) of the Internal Revenue Code as said court shall determine

Article IX – Restrictions

No part of the net earnings or assets of the not for profit corporation will inure to the benefit of, or be distributable to, its directors, officers, or other private persons. The not for profit corporation may, however, pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set for in the Articles of Incorporation.

No part of the activities of the not for profit corporation may include the carrying on of propaganda or be used to influence legislation as defined in Section 4945 of the Internal Revenue Code. The not for profit corporation may not participate in, or intervene in (including the publishing or distributing of statements) in any political campaign on behalf of any candidate for public office.

The not for profit corporation may not exercise any power or engage directly or indirectly in any activity that would invalidate its status as a corporation exempt from federal income taxation:

- As a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code.

- As a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code.

- As a not for profit corporation organized under the laws of the State of Florida

The not for profit corporation must distribute its income for each tax year at a time and in a manner as not to become subject to the tax on undistributed income imposed by Section 4942 of the Internal Revenue Code. Furthermore, the not for profit corporation must not:

Engage in any act of self-dealing as defined in Section 4941(d) of the Internal Revenue Code.
Retain any excess business holdings as defined in Section 4943(c) of the Internal Revenue Code.
Make any investments in a manner that would subject it to tax under Section 4944 of the Internal Revenue Code.
Make any taxable expenditures as defined in Section 4945(d) of the Internal Revenue Code.

Article X – Board of Directors

The not for profit corporation is organized on a non-stock basis. The Board of Directors will have authority for all affairs of the not for profit corporation and may exercise all powers as permitted by federal law, state law, Articles of Incorporation, and By-Laws of the not for profit corporation. After the initial Board of Directors is organized, it may change the number of directors in a manner provided in the By-Laws and consistent with the laws of the State of Florida.

Article XI – By-Laws

The Board of Directors shall adopt, amend and repeal from time to time, the By-Laws of the not for profit corporation.

Article XII – Amendments

The not for profit corporation may amend the Articles of Incorporation in a manner provided by the laws of the State of Florida. But no amendment may authorize the Board of Directors to conduct the affairs of the not for profit corporation in a manner or for any purpose contrary to the provisions of Section 501(c)(3) of the Internal Revenue Code.
