# ARTICLES OF INCORPORATION OF ARMEN GROVES HOMEOWNERS ASSOCIATION, INC. (A NOT-FOR-PROFIT CORPORATION)

In compliance with the requirements of the laws of the State of Florida, and for the purpose of forming a not-for-profit corporation, the undersigned does hereby acknowledge:

- 1 Name of Corporation The name of the corporation is ARMEN GROVES HOMEOWNERS ASSOCIATION, INC., a Florida not-for-profit corporation (the 'Association')
- 2 <u>Principal Office</u> The principal office of the Association is 2301 Lucien Way, Suite 280, Mailland, Frontica 32751.
- 3 Registered Office Registered Agent. The street address of the Registered Office of the Association is 1170 Celebration Boulevard, #202 Celebration, Florida 34747. The name of the Registered Agent of the Association is:

- <u>Definitions.</u> The COMMUNITY DECLARATION FOR ARMEN GROVES (the "<u>Declaration</u>") will be recorded in the Public Records of Brevard County, Florida, and shall govern all of the operations of a community to be known as ARMEN GROVES. All initially capitalized terms not defined herein shall have the meanings set forth in the Declaration.
- Purpose of the Association. The Association is formed to (i) provine for ownership, operation, maintenance and preservation of the Common Areas, and improvements thereon, (ii) perform the duties delegated to it in the Declaration, Bylaws and those Articles; and (iii) administer the rights and obligations of the Association and the Owners pursuant to the Declaration.
- 6 Not for Profit. The Association is a not for profit Florida corporation and does not contemp'ate becuniary gain to, or profit for, its members.
- 7 <u>Powers of the Association.</u> The Association shall, subject to the limitations and reservations set forth in the Declaration, have all the powers, privileges and duties reasonably necessary to discharge its obligations, including, but not limited to, the following.
- 7.1 To perform all the duties and obligations of the Association set forth in the Declaration and Bylaws, as herein provided:
- 7.2 To enforce, by legal action or otherwise, the provisions of the Declaration and Bylaws and of all rules, regulations, occurrants, restrictions and agreements governing or binding Association and ARMEN GROVES;
- 7.3 To fix, levy, collect and enforce payment, by any lawful means, of all Assessments pursuant to the terms of the Declaration, these Articles and Bylaws.
- 7.4 To pay all Operating Expenses, including, but not limited to, all licenses, taxes or governmental charges levied or imposed against the property of the Association;
- 7.5 To acquire (by gift curchase or otherwise), annex, own, hold, improve, build upon, operate, maintain, convey, grant rights and easements, sell, dedicate, lease transfer or otherwise dispose of real or personal property (including the Common Areas) in connection with the functions of the Association except as limited by the Declaration.

- To borrow money, and (i) if prior to the Turnover Date, upon the approval of (a) a majority of the Board, and (b) the written consent of the Declarant, or (ii) from and after the Turnover Date, approval of (a) a majority of the Board, and (b) fifty-one percent (51%) of the Voting Interests present (in person or by proxy) at a duly noticed meeting of the members, mortgage, pledge, deed in trust, or hypothecate any or all of its real or personal property as security for money borrowed or debts incurred, including without limitation, the right to collateralize any such inceptedness with the Association's Assessment collection rights.
- 7.7 To dedicate, grant, license, lease, concession, create easements upon, sell or transfer all or any part of ARMEN GROVES to any public agency, entity, authority, utility or other person or entity for such purposes and subject to such conditions as it determines and as provided in the Declaration;
- 7.8 To participate in mergers and consolidations with other non-profit corporations organized for the same purposes,
- 7.9 To adopt, publish, promulgate or enforce rules, regulations, covenants, restrictions or agreements governing the Association, ARMEN GROVES, the Common Areas, Lots, Parcels and Homes as provided in the Declaration and to effectuate all of the purposes for which the Association is organized;
- 7.10. To have and exercise any and all powers rights, and orivileges which a corporation organized under Chapter 617 or Chapter 720, Florida Statutes by law may now or hereafter have or exercise;
- 7.11 To employ personnel and retain independent contractors to contract for management of the Association, ARMEN GROVES, and the Common Areas as provided in the Declaration and to delegate in such contract all or any part of the powers and duties of the Association;
- 7.12 To contract for services to be provided to, or for the benefit of, the Association, Cwners, the Common Areas, and ARMEN GROVES, as provided in the Declaration, such as, but not limited to, telecommunications services, maintenance, garbage pick-up, and utility services;
  - 7.13 To establish committees and delegate certain of its functions to those committees; and
  - 7.14 To have the power to sue and be sued.
- 8 <u>Voting Rights</u>. Owners and the Declarant shall have the voting rights set forth in the Declaration.
- 9. <u>Board of Cirectors</u> The artains of the Association shall be managed by a Board of odd number with not less than three (3) or more than five (5) members. The initial number of Directors shall be three (3). Board members shall be appointed and/or elected as stated in the Bylaws. After the Turnover Date, the election of Directors shall be held at the annual meeting. The names and addresses of the members of the first Board who shall hold office until their successors are appointed or elected, or until removed, are as

consolidation, any member may petitlon the Circuit Court having jurisdiction of the Judidal Circuit of the State of Florida for the appointment of a receiver to manage the attains of the dissolved Association, to manage the Common Areas in the place and stead of the Association, and to make such provisions as may be necessary for the continued management of the affairs of the dissolved Association.

11. <u>Duration</u> Existence of the Association shall commence with the filing of these Articles with the Secretary of State, Tallahessee, Florida. The Association shall exist in perpetuity.

#### Amenaments.

- 12.1 General Restrictors on Amendments. Notwithstanding any other provision herein to the contrary, no amendment to these Articles shall affect the rights of the Declarant unless such amendment receives the prior written consent of the Declarant, which may be withheld for any reason whatsoever. If the prior written approval of any governmental entity or agency having jurisdiction is required by applicable law or governmental regulation for any amendment to these Articles, then the prior written consent of such entity or agency must also be obtained. No amendment shall be effective until it is recorded in the Public Reports.
- 12.2 Amenaments prior to the Turnover. Prior to the Turnover, but subject to the general restrictions on amenaments set forth above, the Declarant shall have the right to amend these Articles as it deems appropriate, without the joinuler or consent of any person or entity whatsoever, except to the extent limited by applicable law as of the date the Declaration is recorded. The Declarant's right to amend under this Section is to be construed as croadly as possible. In the event that the Association shall desire to amend these Articles prior to the Turnover, the Association must first obtain the Declarant's prior written consent to any proposed amendment. An amendment identical to that approved by the Declarant may be adopted by the Association pursuant to the requirements for amendments from and after the Turnover. The Declarant shall join in such identical amendment so that its consent to the same will be reflected in the Public Records.
- 12.3 <u>Amendments From and After the Turnover.</u> After the Turnover, but subject to the general restrictions on amendments set forth above, these Articles may be amended with the approval of (i) a majority of the Board; and (ii) fifty-one percent (51%) of the Voting Interests present (in person or by proxy) at a culy noticed meeting of the members.
- Compliance with HUD, FHA, VA, FNMA, GNMA and SJRWMD. Prior to the Turricver, the Declarant shall have the right to amend these Articles, from time to time, to make such changes, modifications and additions therein and thereto as may be requested or required by HUD, FHA, VA, FNMA. GNMA, SJRWMD, or any other governmental agency or body as a condition to, or in connection with such agency's or body's regulatory requirements or agreement to make, purchase, accept, insure, guaranty or etherwise approve loans secured by mortgages on Lots. No approval or joinder of the Association, other Owners, or any other party shalf be required or necessary to such americanent. After the Tomover, but subject to the general restrictions on amendments set forth above, the Board shall have the right to amend meše Articles, from time to time, to make such changes, modifications and additions therein and thereto as may be requested or required by HUD. In addition, the Board may amend these Articles as it deems necessary or appropriate to make the terms of those Artiples consistent with applicable law in effect from time to time. No approval or joinder of the Owners, or any other party shall be required or necessary to any such amendments by the Board. Any such amendments by the Board shall require the approval of a majority of the Board.

#### 13. <u>Limitations</u>

13.1 <u>Declaration is Paramount.</u> No amendment may be made to these Articles which shall in any manner reduce, amend, affect or modify the terms, conditions, provisions, rights and obligations selforth in the Declaration.

- 13.2 <u>Rights of Deciarant.</u> There shall be no amendment to these Articles which shall abridge, reduce, amend, effect or modify the rights of the Declarant.
  - 13.3 Bylaws. These Articles shall not be amended in a manner that conflicts with the Bylaws.
- 14. Otticers. The Board shall elect a President, Vice President, Secretary, Treasurer, and as many Vice Presidents, Assistant Secretaries and Assistant Treasurers as the Board shall from time to time determine. The foregoing fights anall be in addition to, and not exclusive of, all other rights to which such Director or Officers may be

No Director or Officer of the Association shall incur liability by reason of the fact that such Director or Officer may be interested in any such contract or transaction interested Directors shall disclose the general nature of their interest and may be counted in determining the presence of a quorum at a meeting of the Board which authorized the contract or transaction.
