



**ARTICLES OF INCORPORATION
(Not for Profit)
OF
TEAM UNDERDOG, INC.**

Article I – Name

The name of the Corporation shall be Team Underdog, Inc.

Article II – Address of Corporation

The principal address of the Corporation and the mailing address shall be:

Article III - Purpose

The purpose for which this Corporation is organized is to help facilitate the adoption of dogs which may be considered less desirable in society. To further such purpose, the corporation will provide financial support and assistance to shelters, rescue centers, and individuals in order to subsidize the medical treatment and/or training of injured or abused dogs; the corporation will endeavor to raise awareness of dog safety in schools; and, further, the corporation will engage in such other activities that seek either to educate the public about abused dogs or that will enhance the health, safety and well-being of such neglected animals.

The Corporation is organized exclusively for charitable, religious, educational, and scientific purposes under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Upon the dissolution or winding up of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

Article IV – Manner of Election
