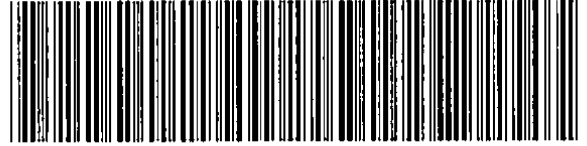

BYLAWS

1. The officers of the corporation will consist of a:

President	Vice President
Treasurer	Administrator
Assist Administrator	Pastor
