Articles of Incorporation
Battle of Bayport Chapter, National Society Daughters of the Union 1861-1865

Article I. Name

The name of the corporation shall be: Battle of Bayport Chapter, National Society Daughters of the Union, Inc.

Article II. Principal Office

6576 Seaway Drive, Brooksville, FL 34604

Article III. Purpose

The Battle of Bayport Chapter is a local chapter subordinate to the National Society Daughters of the Union 1861-1865, Inc. As a subordinate chapter, its primary purpose is the same as the national society: to honor the memory of the men and women who contributed towards the preservation of the Union during the Civil War, to foster a spirit of patriotism, loyalty, and love of country, to uphold the honor of the Flag of the United States of America and to give financial aid to Lincoln Memorial University, Harrogate, TN. The society also supports Hindman Settlement School, Hindman, KY, and the national Wreaths Across America program at Andersonville National Cemetery.

Article IV. Manner of Election. The officers of the chapter are elected as specified in the chapter bylaws.

Article VI. Dissolution

Although the period of duration of the Chapter is perpetual, if for any reason the Chapter is to be dissolved or otherwise terminated, no part of the property of the Chapter or any of the proceeds shall be distributed to or inure to the benefit of any of the officers or members of the Chapter. Upon the dissolution of the Chapter, assets shall be distributed by the Executive Board to and only to the National Society. Any such assets not so disposed of shall be disposed of by the local United States District Court, exclusively to such organization or organizations as said Court shall determine, which are organized and operated within the meaning of section 501(c)(3), with purposes and objectives consistent with those of the Chapter.
