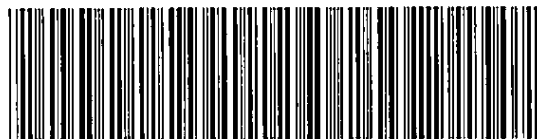

**ARTICLE I**

The name of the Corporation is: **DONALD F. CLARKE FOUNDATION, INC.**

**ARTICLE II**

The existence of the Corporation shall begin on the date these Articles of Incorporation are accepted by the Florida Department of State, as evidenced by the department's endorsement of the date and time of filing.

**ARTICLE III**

The street address of the principal office of the Corporation is: **1641 N 71th Street, Hollywood, FL 33024.**

**ARTICLE IV**

The specific purpose for which the Corporation is organized is to provide opportunities, resources, initiatives, and financial assistances to children and youth for advancement and progress.

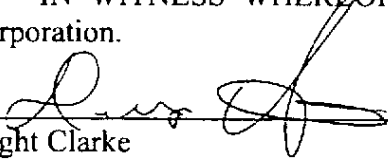

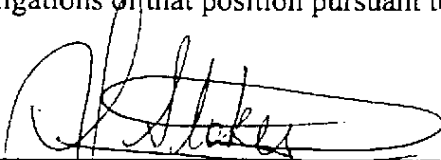

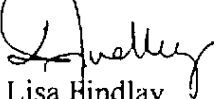
