



ARTICLES OF INCORPORATION FOR MARINA VILLAS AT CAPE HARBOUR OWNERS' ASSOCIATION, INC.

The undersigned incorporator, for the purpose of forming a corporation not for profit pursuant to the laws of the State of Florida, hereby adopts the following Articles of Incorporation:

ARTICLE 1 NAME

The name of the corporation shall be MARINA VILLAS AT CAPE HARBOUR OWNERS' ASSOCIATION, INC. For convenience, the corporation shall be referred to in this instrument as the "Association" or "MVCH Association", these Articles of Incorporation as the "Articles", and the By-Laws of the MVCH Association as the "By-Laws".

ARTICLE 2 OFFICE

The principal office and mailing address of the MVCH Association shall be at 550 Biltmore Way, Suite 1110, Coral Gables, Florida 33134, or at such other place as may be subsequently designated by the Board of Directors. All books and records of the MVCH Association shall be kept at its principal office or at such other place as may be permitted by the Act.

ARTICLE 3 PURPOSE

The objects and purposes of the MVCH Association are those objects and purposes as are authorized by the DECLARATION OF COVENANTS, RESTRICTIONS AND EASEMENTS FOR MARINA VILLAS AT CAPE HARBOUR, recorded (or to be recorded) in the Public Records of Lee County Florida, as hereafter amended and/or supplemented from time to time (the "Declaration" or "MVCH Covenants"). All of the definitions set forth in the MVCH Covenants are hereby incorporated herein by this reference. The further objects and purposes of the MVCH Association are to preserve the values and amenities in The Properties and to maintain the Common Properties thereof for the benefit of the Owners who become Members of the MVCH Association.

ARTICLE 4 DEFINITIONS

The terms used in these Articles shall have the same definitions and meanings as those set forth in the MVCH Covenants, unless herein provided to the contrary, or unless the context otherwise requires.

ARTICLE 5 POWERS

The powers of the MVCH Association shall include and be governed by the following:

- 5.1 <u>General</u>. The MVCH Association shall have all of the common-law and statutory powers of a corporation not for profit under the Laws of Florida, except as expressly limited or restricted by applicable law, the terms of these Articles, the MVCH Covenants or the By-Laws.
- 5.2 <u>Enumeration</u>. In addition to the powers set forth in Section 5.1 above, the MVCH Association shall have all of the powers and duties set forth in the MVCH Covenants and all of the powers and duties reasonably necessary to operate The Properties pursuant to the MVCH Covenants and as more particularly described in the By-Laws, as they may be amended from time to time, including, but not limited to, the following:
 - (a) To make and collect Assessments and other charges against members as Owners (whether or not such sums are due and payable to the MVCH Association), and to use the proceeds thereof in the exercise of its powers and duties.
 - (b) To buy, accept, own, operate, lease, sell, trade and mortgage both real and personal property in accordance with the provisions of the MVCH Covenants.
 - (c) To maintain, repair, replace, reconstruct, add to and operate the Common Properties, MVCH Association Maintenance Areas and other property acquired or leased by the MVCH Association, in accordance with the provisions of the MVCH Covenants.
 - (d) To purchase insurance upon the Common Properties and insurance for the protection of the MVCH Association, its officers, directors and Owners.
 - (e) To make and amend reasonable rules and regulations for the maintenance, conservation and use of The Properties and for the health, comfort, safety and welfare of the Owners.
 - (f) To approve or disapprove the leasing, transfer, ownership and possession of Units as may be provided by the MVCH Covenants.
 - (g) To enforce by legal means the provisions of the MVCH Covenants, these Articles, the By-Laws, the rules and regulations for the use of the Common Properties and applicable law.
 - (h) To contract for the management and maintenance of the Common Properties and to authorize a management agent (which may be an affiliate of the Declarant) to assist the MVCH Association in carrying out its powers and duties by performing such functions as the submission of proposals, collection of Assessments, preparation of records, enforcement of rules and maintenance, repair and replacement of the Common Properties with such funds as shall be made available by the MVCH Association for such purposes. The MVCH Association and its officers shall, however, retain at all times the powers and duties to make Assessments, promulgate rules and execute contracts on behalf of the MVCH Association.
 - (i) To employ personnel to perform the services required for the proper operation of the Common Properties.
 - (j) To (i) operate and maintain the surface water management system in accordance with the permit issued by the applicable water management district (the "District"), (ii) carry out,

maintain, and monitor any required wetland mitigation tasks and (iii) maintain copies of all permitting actions with regard to the District.

- (k) To assume all of Declarant's and its affiliates' responsibilities to the State of Florida, the County, the City, and its and their governmental and quasi-governmental subdivisions and similar entities of any kind with respect to the Common Properties (including, without limitation, any and all obligations imposed by any permits or approvals issued by the City, as same may be amended, modified or interpreted from time to time) and indemnify and hold Declarant and its affiliates harmless with respect thereto in the event of the MVCH Association's failure to fulfill those responsibilities.
- (I) To execute all documents or consents, on behalf of all Owners (and their mortgagees), required by all governmental and/or quasi-governmental agencies in connection with land use and development matters (including, without limitation, plats, waivers of plat, unities of title, covenants in lieu thereof, etc.), and in that regard, each Owner, by acceptance of the deed to such Owner's Unit, and each mortgagee of a Unit Owner by acceptance of a lien on said Unit, appoints and designates the President of the MVCH Association as such Owner's and mortgagee's agent and attorney-in-fact to execute any and all such documents or consents.
- 5.3 <u>MVCH Association Property</u>. All funds and the title to all properties acquired by the MVCH Association and their proceeds shall be held for the benefit and use of the members in accordance with the provisions of the MVCH Covenants, these Articles and the By-Laws.
- 5.4 <u>Distribution of Income</u>; <u>Dissolution</u>. The MVCH Association shall not pay a dividend to its members and shall make no distribution of income to its members, directors or officers, and upon dissolution, all assets of the MVCH Association shall be transferred only to another non-profit corporation or a public agency or as otherwise authorized by the Florida Not For Profit Corporation Act (Chapter 617, Florida Statutes).
- 5.5 <u>Limitation</u>. Notwithstanding anything contained in the MVCH Covenants, the By-Laws or these Articles to the contrary before commencing litigation against any party in the name of the MVCH Association involving amounts in controversy in excess of One Hundred Thousand and No/100 Dollars (\$100,000.00), the MVCH Association must obtain the affirmative approval of a majority of the voting interests at a meeting of the membership at which a quorum has been attained. The powers of the MVCH Association shall be subject to and shall be exercised in accordance with the provisions hereof and of the MVCH Covenants, the By-Laws and applicable law, provided that in the event of conflict, the provisions of applicable law shall control over those of the MVCH Covenants and By-Laws.

ARTICLE 6 MEMBERS

6.1 <u>Membership</u>. The members of the MVCH Association shall consist of the Declarant and all persons or entities who are, from time to time, record Owners of a fee interest in any Parcel, provided, however, that as to any Condominium Parcel, each Unit Owner shall be deemed to be the Member of the MVCH Association. Notwithstanding anything else to the contrary, any such person or entity who holds such interest merely as security for the performance of an obligation shall not be a Member of the MVCH Association.

- 6.2 <u>Assignment</u>. The share of a member in the funds and assets of the MVCH Association cannot be assigned, hypothecated or transferred in any manner except as an appurtenance to the Parcel for which that share is held.
 - 6.3 <u>Voting.</u> The MVCH Association shall have two (2) classes of voting membership:

<u>Class A Members</u> shall be all those Owners (including Condominium Unit Owners), as defined in Section 6.1, with the exception of the "Declarant" (as long as the Class B Membership shall exist, and thereafter, the Declarant shall be a Class A Member to the extent it would otherwise qualify). Each Parcel shall have the number of votes attributable to it which is equal to the number of Assessment Points allocated to it under the MVCH Covenants.

Notwithstanding the foregoing, Class A Members who are governed by a Parcel Specific Manager (e.g., a Parcel submitted to the condominium form of ownership) shall only vote through a Voting Member and said Class A Members shall be entitled to elect from among themselves, respectively, one Voting Member for each such Parcel, each such Voting Member to have and cast the number of votes equal to the aggregate of the votes entitled to be cast by the Owners within the applicable Parcel. The first election of such Voting Member for a particular Parcel shall be conducted at or immediately following the meeting at which control of such Parcel Specific Manager is turned over to its members other than the developer/declarant (i.e., at which the non-developer/declarant members elect a majority of the board of directors) and prior to such time, the Voting Member for the members within the Parcel Specific Manager shall be the developer of the community governed by the Parcel Specific Manager. At such time, and at all times thereafter, the Parcel Specific Manager shall elect its Voting Member in the same manner as it elects its board of directors, subject to the same rules as those applicable to its directors as to the term of office, removal, replacement and other matters. In the event that the members of a Parcel Specific Manager do not elect a Voting Member, the President of such Association shall perform the duties of the Voting Member.

<u>Class B Member</u>. The Class B Voting Member shall be the Declarant, or a representative thereof, who shall have and cast one (1) vote in all MVCH Association matters, plus two (2) votes for each vote which may be cast, in the aggregate, by the Class A Members and/or Voting Members. Such Class B Voting Member may be removed and replaced by the Declarant in its sole discretion. The Class B Membership shall cease and terminate at such time as the Declarant elects, but in no event later than the time period set forth in Section 6.5 below.

All votes shall be exercised or cast in the manner provided by the MVCH Covenants and By-Laws.

- 6.4 <u>Meetings</u>. The By-Laws shall provide for an annual meeting of Members, and may make provision for regular and special meetings of Members other than the annual meeting.
- 6.5 <u>Turnover</u>. Unless the Class B Voting Member elects to terminate the Class B Membership sooner, the Class B Membership shall cease and terminate three (3) months after ninety (90%) percent of the aggregate of the Units (which are part of any Condominium Parcels) and Parcels (which are first a

Condominium Parcel) that will be operated ultimately by the MVCH Association (including those which may be within the Future Development Property, unless Declarant has put of record a written certification relinquishing the right to submit the Future Development Property to The Properties) have been conveyed to purchasers (other than purchasers who are builders, contractors, or others who purchase a Parcel for the purpose of constructing improvements thereon for resale). The Declarant is entitled (but not obligated) to designate at least one (1) member of the Board of Directors as long as the Declarant holds for sale in the ordinary course of business five percent (5%) of the Units (as to Condominium Parcels) and Parcels that will be operated ultimately by the MVCH Association (including those which may be within the Future Development Property, unless Declarant has put of record a written certification relinquishing the right to submit the Future Development Property to The Properties).

The Declarant may transfer control of the MVCH Association to Unit Owners other than the Declarant prior to such dates in its sole discretion by causing enough of its appointed Directors to resign, whereupon it shall be the affirmative obligation of Unit Owners other than the Declarant to elect Directors and assume control of the MVCH Association. Provided at least thirty (30) days' notice of Declarant's decision to cause its appointees to resign is given to Unit Owners, neither the Declarant, nor such appointees, shall be liable in any manner in connection with such resignations even if the Unit Owners other than the Declarant refuse or fail to assume control.



ARTICLE 8 TERM OF EXISTENCE

The MVCH Association shall have perpetual existence. In the event that the MVCH Association is dissolved, and to the extent that responsibility for the surface water management system is the responsibility of the MVCH Association, then the property consisting of the surface water management system and the right of access to the portions of the Condominium Property containing the surface water management system shall be conveyed to an appropriate agency of local government. If it is not accepted, then the surface water management system must be dedicated to a similar non-profit corporation.



ARTICLE 9 OFFICERS

The affairs of the MVCH Association shall be administered by the officers holding the offices designated in the By-Laws. The officers shall be elected by the Board of Directors of the MVCH Association at its first meeting following the annual meeting of the Members of the MVCH Association and shall serve at the pleasure of the Board of Directors. The By-Laws may provide for the removal from office of officers, for filling vacancies and for the duties and qualifications of the officers. The names and addresses of the officers who shall serve until their successors are designated by the Board of Directors are as follows:

ARTICLE 10 DIRECTORS

- 10.1 <u>Number and Qualification</u>. The property, business and affairs of the MVCH Association shall be managed by a Board of Directors, which shall consist of three (3) persons appointed by the Declarant for so long as the Class B Membership exists. At such time as the Class B Membership expires, the Board shall consist of five (5) persons. A majority of the directors in office shall constitute a quorum for the transaction of business. Directors need not be Members of the MVCH Association.
- 10.2 <u>Duties and Powers</u>. All of the duties and powers of the MVCH Association existing under the Act, the MVCH Covenants, these Articles and the By-Laws shall be exercised exclusively by the Board of Directors, its agents, contractors or employees, subject only to approval by Unit Owners through their Voting Members when such approval is specifically required.
- 10.3 <u>Appointment/Election of Members of Board of Directors</u>. From and after the time that the Class B Membership expires, Directors of the MVCH Association shall be elected at the annual meeting of the Members in the manner determined by and subject to the qualifications set forth in the By-Laws. Directors may be removed and vacancies on the Board of Directors shall be filled in the manner provided by the By-Laws.
- 10.4 <u>Term of Declarant's Directors</u>. The Declarant shall appoint the Members of the first Board of Directors and their replacements who shall hold office for the periods described in the By-Laws.
- 10.5 <u>First Directors</u>. The names and addresses of the Members of the first Board of Directors who shall hold office until their successors are elected and have taken office, as provided in the By ways, we are as follows:

10.6 <u>Standards.</u> A Director shall discharge his duties as a director, including any duties as a Member of a Committee: in good faith; with the care an ordinary prudent person in a like position would exercise under similar circumstances; and in a manner reasonably believed to be in the best interests of the MVCH Association. Unless a Director has knowledge concerning a matter in question that makes reliance unwarranted, a Director, in discharging his duties, may rely on information, opinions, reports or statements, including financial statements and other data, if prepared or presented by: one or more officers or employees of the MVCH Association whom the Director reasonably believes to be reasonable and competent in the manners presented; legal counsel, public accountants or other persons as to matters the Director reasonably believes are within the persons' professional or expert competence; or a Committee of which the Director is not a Member if the Director reasonably believes the Committee merits confidence. A Director is not liable for any action taken as a director, or any failure to take action, if he performed the duties of his office in compliance with the foregoing standards.

ARTICLE 11 INDEMNIFICATION PROVISIONS

- 11.1 <u>Indemnitees</u>. The MVCH Association shall indemnify any person who was or is a party to any proceeding (other than an action by, or in the right of, the MVCH Association) by reason of the fact that he is or was a director, officer, employee or agent (each, an "Indemnitee") of the MVCH Association, against liability incurred in connection with such proceeding, including any appeal thereof, if he acted in good faith and in a manner he reasonably believed to be in, or not opposed to, the best interests of the MVCH Association and, with respect to any criminal action or proceeding, had no reasonable cause to believe his conduct was unlawful. The termination of any proceeding by judgment, order, settlement, or conviction or upon a plea of nolo contendere or its equivalent shall not, of itself, create a presumption that the person did not act in good faith and in a manner which he reasonably believed to be in, or not opposed to, the best interests of the MVCH Association or, with respect to any criminal action or proceeding, had reasonable cause to believe that his conduct was unlawful.
- 11.2 <u>Indemnification</u>. The MVCH Association shall indemnify any person, who was or is a party to any proceeding by or in the right of the MVCH Association to procure a judgment in its favor by reason of the fact that he is or was a director, officer, employee, or agent of the MVCH Association against expenses and amounts paid in settlement not exceeding, in the judgment of the board of directors, the estimated expense of litigating the proceeding to conclusion, actually and reasonably incurred in connection with the defense or settlement of such proceeding, including any appeal thereof. Such indemnification shall be authorized if such person acted in good faith and in a manner he reasonably believed to be in, or not opposed to, the best interests of the MVCH Association, except that no indemnification shall be made under this subsection in respect of any claim, issue, or matter as to which such person shall have been adjudged to be liable unless, and only to the extent that, the court in which

such proceeding was brought, or any other court of competent jurisdiction, shall determine upon application that, despite the adjudication of liability but in view of all circumstances of the case, such person is fairly and reasonably entitled to indemnity for such expenses which such court shall deem proper.

- 11.3 <u>Indemnification for Expenses</u>. To the extent that a director, officer, employee, or agent of the MVCH Association has been successful on the merits or otherwise in defense of any proceeding referred to in subsection 11.1 or 11.2, or in defense of any claim, issue, or matter therein, he shall be indemnified against expenses actually and reasonably incurred by him in connection therewith.
- 11.4 <u>Determination of Applicability</u>. Any indemnification under subsection 11.1 or subsection 11.2, unless pursuant to a determination by a court, shall be made by the MVCH Association only as authorized in the specific case upon a determination that indemnification of the director, officer, employee, or agent is proper under the circumstances because he has met the applicable standard of conduct set forth in subsection 11.1 or subsection 11.2. Such determination shall be made:
 - (a) By the board of directors by a majority vote of a quorum consisting of directors who were not parties to such proceeding;
 - (b) If such a quorum is not obtainable or, even if obtainable, by majority vote of a Committee duly designated by the Board of Directors (in which directors who are parties may participate) consisting solely of two or more Directors not at the time parties to the proceeding;
 - (c) By independent legal counsel:
 - (i) selected by the Board of Directors prescribed in paragraph (a) or the committee prescribed in paragraph (b); or
 - (ii) if a quorum of the Directors cannot be obtained for paragraph (a) and the Committee cannot be designated under paragraph (b), selected by majority vote of the full Board of Directors (in which Directors who are parties may participate); or
 - (d) By a majority of the voting interests of the Members of the MVCH Association who were not parties to such proceeding.
- 11.5 <u>Determination Regarding Expenses</u>. Evaluation of the reasonableness of expenses and authorization of indemnification shall be made in the same manner as the determination that indemnification is permissible. However, if the determination of permissibility is made by independent legal counsel, persons specified by paragraph 10.5 shall evaluate the reasonableness of expenses and may authorize indemnification.
- Advancing Expenses. Expenses incurred by an officer or director in defending a civil or criminal proceeding may be paid by the MVCH Association in advance of the final disposition of such proceeding upon receipt of an undertaking by or on behalf of such director or officer to repay such amount if he is ultimately found not to be entitled to indemnification by the MVCH Association pursuant to this section. Expenses incurred by other employees and agents may be paid in advance upon such terms or conditions that the Board of Directors deems appropriate.

- 11.7 Exclusivity; Exclusions. The indemnification and advancement of expenses provided pursuant to this section are not exclusive, and the MVCH Association may make any other or further indemnification or advancement of expenses of any of its directors, officers, employees, or agents, under any bylaw, agreement, vote of shareholders or disinterested directors, or otherwise, both as to action in his official capacity and as to action in another capacity while holding such office. However, indemnification or advancement of expenses shall not be made to or on behalf of any director, officer, employee, or agent if a judgment or other final adjudication establishes that his actions, or omissions to act, were material to the cause of action so adjudicated and constitute:
 - (a) A violation of the criminal law, unless the director, officer, employee, or agent had reasonable cause to believe his conduct was lawful or had no reasonable cause to believe his conduct was unlawful;
 - (b) A transaction from which the director, officer, employee, or agent derived an improper personal benefit; or
 - (c) Willful misconduct or a conscious disregard for the best interests of the MVCH Association in a proceeding by or in the right of the MVCH Association to procure a judgment in its favor or in a proceeding by or in the right of the Members of the MVCH Association.
- 11.8 <u>Continuing Effect</u>. Indemnification and advancement of expenses as provided in this section shall continue as, unless otherwise provided when authorized or ratified, to a person who has ceased to be a director, officer, employee, or agent and shall inure to the benefit of the heirs, executors, and administrators of such a person, unless otherwise provided when authorized or ratified.
- 11.9 Application to Court. Notwithstanding the failure of the MVCH Association to provide indemnification, and despite any contrary determination of the Board or of the Members in the specific case, a director, officer, employee, or agent of the MVCH Association who is or was a party to a proceeding may apply for indemnification or advancement of expenses, or both, to the court conducting the proceeding, to the circuit court, or to another court of competent jurisdiction. On receipt of an application, the court, after giving any notice that it considers necessary, may order indemnification and advancement of expenses, including expenses incurred in seeking court-ordered indemnification or advancement of expenses, if it determines that:
 - (a) The director, officer, employee, or agent is entitled to mandatory indemnification under subsection 11.3 in which case the court shall also order the MVCH Association to pay the director reasonable expenses incurred in obtaining court-ordered indemnification or advancement of expenses;
 - (b) The director, officer, employee, or agent is entitled to indemnification or advancement of expenses, or both, by virtue of the exercise by the MVCH Association of its power pursuant to subsection 11.7; or
 - (c) The director, officer, employee, or agent is fairly and reasonably entitled to indemnification or advancement of expenses, or both, in view of all the relevant circumstances, regardless of whether such person met the standard of conduct set forth in subsection 11.1, subsection 11.2, or subsection 11.7, unless (a) a court of competent jurisdiction determines after all available appeals have been exhausted or not pursued by the proposed indemnitee, that he is

did not act in good faith or acted in a manner he reasonably believed to be not in, or opposed to, the best interest of the MVCH Association, and, with respect to any criminal action or proceeding, that he had reasonable cause to believe his conduct was unlawful, and (b) such court further specifically determines that indemnification should be denied. The termination of any proceeding by judgment, order, settlement, conviction or upon a plea of nolo contendere or its equivalent shall not, of itself, create a presumption that the person did not act in good faith or did act in a manner which he reasonably believed to be not in, or opposed to, the best interest of the MVCH Association, and, with respect to any criminal action or proceeding, that he had reasonable cause to believe that his conduct was unlawful.

- 11.10 <u>Definitions</u>. For purposes of this Article 11, the term "expenses" shall be deemed to include attorneys' fees, including those for any appeals; the term "liability" shall be deemed to include obligations to pay a judgment, settlement, penalty, fine, and expenses actually and reasonably incurred with respect to a proceeding; the term "proceeding" shall be deemed to include any threatened, pending, or completed action, suit, or other type of proceeding, whether civil, criminal, administrative or investigative, and whether formal or informal; and the term "agent" shall be deemed to include a volunteer; the term "serving at the request of the MVCH Association" shall be deemed to include any service as a director, officer, employee or agent of the MVCH Association that imposes duties on such persons.
- 11.11 <u>Amendment</u>. Anything to the contrary herein notwithstanding, no amendment to the provisions of this Article 11 shall be applicable as to any party eligible for indemnification hereunder who has not given his prior written consent to such amendment.

ARTICLE 12 BY-LAWS

The first By-Laws of the MVCH Association shall be adopted by the Board of Directors and may be altered, amended or rescinded in the manner provided in the By-Laws and the MVCH Covenants.

ARTICLE 13 AMENDMENTS

Amendments to these Articles shall be proposed and adopted in the following manner:

- 13.1 <u>Notice</u>. Notice of a proposed amendment shall be included in the notice of any meeting at which the proposed amendment is to be considered and shall be otherwise given in the time and manner provided in Chapter 617, Florida Statutes. Such notice shall contain the proposed amendment or a summary of the changes to be affected thereby.
- 13.2 <u>Adoption</u>. Amendments shall be proposed and adopted in the manner provided in Chapter 617, Florida Statutes and in the Act (the latter to control over the former to the extent provided for in the Act).
- 13.3 <u>Declarant Amendments</u>. Notwithstanding anything herein contained to the contrary, to the extent lawful, the Declarant may amend these Articles consistent with the provisions of the WVCH Covenants allowing certain amendments to be effected by the Declarant alone.

13.4 <u>Recording.</u> A copy of each amendment shall be filed with the Secretary of State pursuant to the provisions of applicable Florida law, and a copy certified by the Secretary of State shall be recorded in the public records of Lee County, Florida with an identification on the first page thereof of the book and page of said public records where the MVCH Covenants were recorded which contains, as an exhibit, the initial recording of these Articles.

ARTICLE 14 INITIAL REGISTERED OFFICE;

ADDRESS AND NAME OF REGISTERED AGENT

The initial registered office of this corporation shall be at 550 Biltmore Way, Suite 1110, Coral Gables, Florida 33134, with the privilege of having its office and branch offices at other places within or without the State of Florida.
