The undersigned incorporator hereby makes, subscribes, acknowledges and files with the Secretary of State of the State of Florida these Articles of Incorporation for the purpose of forming a Corporation not for profit in accordance with the laws of the State of Florida.

**ARTICLES I: Name**

The name of this Corporation shall be: Btrue Foundation Corp

**ARTICLE II: Address**

The physical and mailing address of the Corporation is 3516 President Barack Obama Pkwy, Orlando, FL 32811

**ARTICLE III: Purpose**

The specific purpose of the corporation is exclusively for those charitable and educational, and to promote regional, national, or international amateur athletic competition, within the meaning of the 501(c)(3) Internal Revenue Code of 1984, as amended, including for purposes of providing gifts, donating, outreach programs, services and initiatives to individuals and organizations in need, for the promotion of public welfare through sports, health and education.

**ARTICLE IV: Officers & Directors**

The affairs of this Corporation shall be managed by a Board of Directors. The initial Officers and Directors compose of 3 members. The method of election of the officers and directors of the Corporation shall be provided for in the Bylaws of the Corporation. All provisions defining, limiting or regulating the powers and rights of the directors, members, or any class of members including the right to vote and provision for the regulation and conduct of the affairs of the Corporation shall be contained in the Corporate Bylaws. The Bylaws may be amended from time to time by an affirmative vote of a majority of the Board of Directors.

Any such assets not so disposed of shall be disposed of by the Superior Court of Orange County, exclusively for the Corporation's purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for the Corporation's purposes.






