
I am Matthew Keller. I am the former owner of Old Dog Sailing LLC, Doc L22000346709. I authorize the release of the title Old Dog Sailing LLC.

I am trying to set up a nonprofit corporation in Florida. I have never done this before and I made the mistake of forming an LLC instead of a nonprofit. I have submitted a 1023 with the IRS. They told me an LLC can not be a nonprofit unless it is under another corporation, which I am not. However, they also told me that because the company is less than a year old, and I have not filed any reports with the IRS, my current 1023 can be approved IF I retain the name Old Dog Sailing. If I have to change the name I will have to file a new 1023.

The current 1023 has taken six months to get to this point. I would like you to approve my Florida nonprofit application using the title Old Dog Sailing Inc. This will save me the Florida 120 day waiting period as well as the potential 180 days of IRS processing.
