

The objectives and purposes for which this ministry is constituted, and this corporation are:

The purposes for which the corporation is organized are exclusively religious, charitable, and educational within the meaning of the section 501c3 of the Internal Revenue Code of 1986 or the corresponding provision of any future United State Internal Revenue Law

The body to which such disclosure is made shall thereupon determine, by a vote of seventy-five (75%) of the votes entitled to vote, whether the disclosure shows that a conflict of interest exists or can reasonably be construed to exist. If a conflict is deemed to exist, such person shall not vote on, nor use his personal influence on, nor participate (other than to present information or to respond to questions) in, the discussions or deliberations with respect to such contract or transaction. Such a person may be counted on determining whether a quorum is present but may not be counted when the Board of Directors or a committee of the Board acts on the transaction. The minutes of the meeting shall reflect the disclosure made the vote thereon and, where applicable, the absence from voting and participation, and whether a quorum was present.
