ARTICLES OF INCORPORATION OF HADLEY VILLAGE COMMUNITY ASSOCIATION, INC. (A Florida Corporation Not-For-Profit)

In order to form a corporation not for profit under and in accordance with the provisions of Chapters 617 and 720 of the Florida Statutes, the undersigned hereby incorporates this corporation not for profit for the purposes and with the powers hereinafter set forth and, to that end, the undersigned, by these Articles of Incorporation, certifies as follows:

ARTICLET DEFINITIONS

The following words and parases when used in these Articles of Incorporation (unless the context clearly reflects another meaning) shall have the following meanings, or if not defined below, as defined in the Declaration;

- "Articles" means these Articles of Incorporation and any amendments herefoly 1.
- "Assessments" means the assessments for which all Owners are obligated to the Association and includes "Individual Home Assessments" and "Special Assessments" (as such terms are defined in the Declaration), and any and all other assessments, including but not limited to "Benefited Assessments" (as such term is defined and discussed in the Deciaration) which are levied by the Association in accordance with the Hadley Village Documents.
- "Association" means Hadley Village Community Association, Inc., a Florida corporation not for profit. The "Association" is NOT a condominium association and is not intended to be governed by Chapter 718, the Condominium Act, Florida Statutes.
- "Association Property" means the property more particularly described in Article H of the Declaration
 - "Board" means the Board of Directors of the Association.
 - 6. "Bylaws" means the Bylaws of the Association and any amendments thereto.
- Community Development District" or "CDD" means the Regal Village Community Development District (if established) which is a special purpose government unit organized in accordance with the Uniform Community Development District Act of 1980, Chapter 190, Florida Statutes, as amended, and which may acquire, fund, construct, operate and maintain certain infrastructure and community services within and outside Hadley Village, if the CDD is established.
 - "County" means Miami-Dade County, Florida. 8.
 - 9. "Declarant" means Forestar (USA) Real Estate Group Inc., a Delaware corporation.

- "Hadley Village" means that planned residential development located in the County, which encompasses the Property and is intended to comprise two hundred eighty-two (282) attached Homes together with the Association Property, but is subject to change in accordance with the Declaration.
- "Hadley Village Documents" means in the aggregate the Declaration, these Articles and the Bylaws and all of the instruments and documents referred to therein, including, but not limited to, any "Amendment(s)" and "Supplemental Declaration(s)" (as such terms are defined in the Declaration).
- "HOA Act" means the homeowners' association act, Chapter 720, Plorida Stuppes as amended through the date of recording the Declaration amongst the Public Records of the County.
- "Home" means a residential dwelling unit constructed or to be constructed within-Hadley Village, each of which is designed and intended for use and occupancy as a single-familyresidence. The term Home shall include the Lot.
- "Lot" means any parcel of land within Hadley Village, as shown on the Plat, upon which a Home is permitted to be constructed, together with the improvements thereon, and any portion of the Property within Hadley Village that is declared to be a Lot by a Supplemental Declaration, provided, however, that no portion of any Community System shall be deemed to be part of a Lot unless and until same is made such pursuant to the terms of this Declaration, if at all. Upon completion of construction of the Home on a Lot, such Lot and the Improvements thereon shall collectively be considered to be a Home for purposes of this Declaration and the other Hadley Village Documents. Any portion of Hadley Village owned by the CDD shall not be considered a
 - "Member" means a member of the Association. 17.
- "Operating Expenses" means the expenses for which Owners are liable to the Association as described in this Declaration and any other Hadley Village Documents and include,

but are not limited to, the costs and expenses incurred by the Association in administering, operating, maintaining, financing, or repairing, but not reconstructing, replacing or improving, the Association Property or any portion thereof and Improvements thereon and all costs and expenses incurred by the Association in currying out its powers and duties hereunder or under any other Hadley Village Documents.

- 19. "Owner" means the record owner, whether one or more persons or entities, of the fee simple title to any Lot within Hadiey Village, and includes Declarant for as long as Declarant owns fee simple title to a Lot, but excluding therefrom those having such interest as security for the performance of an obligation.
- 20. "Participating Builder' shall mean D.R. Horton, Inc., a Delaware corporation, and any affiliate of D.R. Horton, Inc. and any other entity(ies) Declarant may designate as a Participating Builder. Declarant shall have the right to assign, in whole or in part, any of its rights hereunder to a Participating Builder(s). "Participating Builders" shall mean Participating Builder and any other entity(ies) designated as a Participating Builder.
- 21. Surface Water or Stormwater Management System" means a system which is designed, constructed, or implemented to control discharges which are necessitated by rainfall events, incorporating methods to collect, convey, store, absorb, inhibit, treat, use, or reuse, water to prevent or reduce flooding, overdrainage, environmental degradation and water pollution, or io otherwise affect the quality and quantity of discharge from the system, as permitted pursuant to Section 373.416(2), Florida Statute and Chapter 62-330, Florida Administrative Code Go the extent not maintained by the CDD (as discussed in the Declaration) or if the CDD is not established, the Association shall be responsible to maintain, repair and operate the Surface Water or Stormwater Management System located on the Property in accordance with the applicated governmental regulations, the District Permit and the Declaration.

Unless otherwise defined herein, the terms defined in the Declaration are incorporated herein by reference and shall appear in initial capital letters each time such terms appears in these Articles.

ARTICLE II NAME

The name of this corporation shall be HADLEY VILLAGE COMMUNITY ASSOCIATION, INC., a Florida corporation not for profit, whose principal address and mailing address is c/o Forestar (USA) Real Estate Group Inc., 6123 Lyons Road, Coconut Creek, Florida 33073.

ARTICLE III PURPOSES

The purpose for which the Association is organized is to take title to, administer, operate, maintain, finance, repair, replace, manage and lease the Association Property in accordance with

the terms of, and purposes set forth in, the Hadley Village Documents and to carry out the covenants and enforce the provisions of the Hadley Village Documents.

ARTICLE IV POWERS

The Association shall have the following powers and shall be governed by the following provisions:

- A. The Association shall have all of the common law and statutory powers of a corporation not for profit.
- B. The Association shall have all of the powers granted to the Association in the Hadley Village Documents. All of the provisions of the Declaration and Bylaws which grant powers to the Association are incorporated into these Articles.
- C. The Association shall have all of the powers reasonably necessary to implement the purposes of the Association, including, but not limited to, the following:
- To perform any act required or contemplated by it under the Hadley-Village Documents.
- 2. To make, establish, amend, abolish (in whole or in part) and enforce reasonable rules and regulations governing the use of the Association Property.
- To make, levy and collect Assessments for the purpose of obtaining finds from its Members to pay Operating Expenses and other costs and expenses defined or idealified in the Declaration and costs of collection, and to use and expend the proceeds of Assessments for the exercise of the powers and duties of the Association. The foregoing shall include the power to levy and collect adequate Assessments for the costs of maintenance, repair and operation of the Surface Water or Stormwater Management System, including, but not limited to, cost associated with maintenance, repair and operation of retention areas, drainage structures and drainage easements, to the extent the Association becomes obligated for the maintenance therefor.
- 4. To own, administer, operate, maintain, finance, repair, replace, manage, lease and convey the Association Property in accordance with the Hadley Village Documents.
- 5. To enforce by legal means the obligations of the Members and the provisions of the Hadley Village Documents.
- 6. To employ personnel, retain independent contractors and professional personnel, and enter into service contracts to provide for the administration, operation, maintenance, financing, repairing, replacing, management and leasing of the Association Property and to enter into any other agreements consistent with the purposes of the Association, including, but not limited to, agreements with respect to professional management of the Association

Property and to delegate to such professional manager certain powers and duties of the Association.

- 7. To enter into the Declaration and any amendments thereto and instruments referred to therein.
- 8. To provide, to the extent deemed necessary by the Board, any and all services and do any and all things which are incidental to or in furtherance of things listed above or to carry out the Association mandate to keep and maintain Hadley Village in a proper and aesthetically pleasing condition and to provide the Owners with services, amenities, controls and enforcement which will enhance the quality of life at Hadley Village.
- 9. To borrow money and to obtain such financing as is necessary to maintain, repair and replace the Association Property in accordance with the Declaration and, as security for any such loan, to collaterally assign the Association's right to collect and enforce Assessments levied for the purpose of repaying any such loan.
- 10. Notwithstanding anything contained herein to the contrary, in order to prevent the Board from incurring expenses not contemplated by the Hadley Village Documents, for which the Owners will be responsible, the Association shall be required to obtain the approval of seventy-five percent (75%) of all Members (at a duly called meeting of the Members at which a quorum is present) prior to the engagement of legal counsel by the Association for the purpose of suing, or making, preparing or investigating any lawsuit, or commencing any lawsuit other than for the following purposes:
 - (a) the collection of Assessments;
- (b) the collection of other charges which Owners are obligated to pay pursuant to the Hadley Village Documents;
- (c) the enforcement of any applicable use and occupancy restrictions contained in the Hadley Village Documents:
- (d) dealing with an emergency when waiting to obtain the approval of the Members creates a substantial risk of ineparable injury to the Association Property or to Member(s) (the imminent expiration of a statute of limitations shall not be deemed an emergency obviating the need for the requisite vote of a seventy-five [75%] of the Members); or
 - (e) filing a compulsory counterclaim.
- II. To the extent maintained by the Association and not the CDD or if the CDD is not established, to operate, maintain, and manage the Surface Water and Storm Water Management System in a manner consistent with the requirements of South Florida Water Management District Permit, as such District Permit may be amended, modified or reissued from

time to time, and applicable District rules, and to assist in the enforcement of the restrictions and covenants contained therein.

12. To exercise and enforce architectural control, maintenance and use restrictions in accordance with the Declaration.

ARTICLE V MEMBERS AND <u>VOTING</u>

The qualification of Members of the Association, the manner of their admission to membership, the manner of the termination of such membership and the manner of voting by Members shall be as follows:

- A. Until such time as the first deed of conveyance of a Home from Declarant to an Owner is recorded amongst the Public Records of the County ("First Conveyance"), the membership of the Association shall be comprised solely of Declarant. Until the First Conveyance, Declarant shall be entitled to east the one (1) and only vote on all matters requiring a vote of the membership.
- B. Upon the First Conveyance. Declarant shall be a Member as to enchange the remaining Homes until each such Home is conveyed to another Owner, and thereupon, and thereafter each and every Owner, including Declarant as to Homes owned by Declarant, shall be a Member and exercise all of the rights and privileges of a Member
- C. Membership in the Association for Owners other than Declarant shall be established by the acquisition of ownership of fee simple title to a Home as evidenced by the recording of an instrument of conveyance amongst the Public Records of the County. Where title to a Home is acquired by conveyance from a party other than Declarant by means of sale, gift, inheritance, devise, judicial decree or otherwise, the person, persons or entity thereby acquiring such Home shall not be a Member unless or until such Owner shall deliver a true copy of a deed or other instrument of acquisition of title to the Association.
 - D. The Association shall have two (2) classes of voting membership:
- 1. Class "A" Members shall be all Members (including builders), with the exception of Declarant while Declarant is a Class "B" Member, each of whom shall be entitled to one (1) vote for each Lot owned.
- 2. Class "B" Member shall be Declarant, who shall be entitled to three (3) times the total number of votes of all Class "A" Members plus one (1) vote. Class "B" membership shall cease and be converted to Class "A" membership upon the earlier to occur of the following events ("Turnover Date"):
- (a) three (3) months after the conveyance of ninety percent (90%) of the "Total Developed Lots" (as defined below) have been conveyed to Owners (other than builders.

contractors, or others who purchase a parcel for the purpose of constructing improvements thereon for resale), as evidenced by the recording of instruments of conveyance of such Homes amongst the Public Records of the County;

- upon the Class "B" Member abandoning or deserting its responsibility to maintain and complete the amenities or infrastructure as disclosed in the Neighborhood Documents. There is a rebuttable presumption that Declarant has abandoned and deserted the Property if Declarant has unpaid Assessments or guaranteed amounts under Section 720.308 of the HOA Act for a period of more than two (2) years;
- upon the Class "B" Member filing a petition seeking protection under Chapter 7 of the Federal Bankruptcy Code;
- upon the Class "B" Member losing title to the Property through a foreclosure action of the transfer of a deed in lieu of foreclosure, unless the successor owner has accepted an assignment of developer rights and responsibilities first arising after the date of such assignment;
- upon a receiver for the Class "B" Member being appointed by a circuit court and not being discharged within 30 days after such appointment, unless the court determines within 30 days after such appointment that transfer of control would be detrimentalled the Association or the Members; or
 - when, in its discretion, the Class "B" Member so determines. T (f)

On the Turnover Date, Class "A" Members, shall assume control of the Association and elect not less than a majority of the Board.

Notwithstanding the foregoing, Class "A" Members are entitled to elect at least one (1) member of the Board when fifty percent (50%) of the Total Developed Lots have been conveyed to Members other than Declarant, builders, contractors, or others who purchase a parcel for the purpose of constructing improvements thereon for resale.

- The designation of different classes of membership are for purposes of establishing the number of votes applicable to certain Homes, and nothing beroin shall be deemed to require voting solely by an individual class on any matter which requires the vote of Members, unless otherwise specifically set forth in the Hadley Village Documents.
- No Member may assign, hypothecate or transfer in any manner his/her membership in the Association except as an appurtenance to his/her Home.
- Any Meinber who conveys or loses title to a Home by sale, gift, devise, bequest, judicial decree or otherwise shall, immediately upon such conveyance or loss of title, no longer be a Member with respect to such Home and shall lose ail rights and privileges of a Member resulting from ownership of such Home.

H. There shall be only one (1) vote for each Home, except for the Class "B" Member as set forth herein. If there is more than one Member with respect to a Home as a result of the fee interest in such Home being held by more than one person, such Members collectively shall be entitled to only one (1) vote. The vote of the Owners of a Home owned by more than one natural person or by a corperation or other legal entity shall be east by the person named in a certificate signed by all of the Owners of the Home, or, if appropriate, by properly designated officers, partners or principals of the respective legal entity ("Voting Member"), and filed with the Secretary of the Association, and such certificate shall be valid until revoked by a subsequent certificate. If such a certificate is not filed with the Secretary of the Association, the Owners of such Home shall lose their right to vote until such a certificate is filed with the Secretary of the Association, but the Home shall be considered for purposes of establishing a quorum.

Netwithstanding the foregoing provisions, whenever any Home is owned by a husband and wife they may, but shall not be required to, designate a Voting Member. In the event a certificate designating a Voting Member is not filed by the husband and wife, the following provisions shall govern their right to vote:

- When both are present at a meeting, each shall be regarded as the agent and proxy of the other for purposes of easting the vote for each Home owned by them. In the event they are unable to concur in their decision upon any topic requiring a vote, they shall losefabling right to vote on that topic at that meeting, but shall count for purposes of establishing a quorum.
- 2. When only one (1) spouse is present at a meeting, the person present may a cast the Home vote without establishing the concurrence of the other spouse, absent any prior written notice to the contrary by the other spouse. In the event of prior written notice to the contrary to the Association by the other spouse, the vote of said Home shall not be considered, but shall count for purposes of establishing a quorum.
- 3. When neither spouse is present, the person designated in a "Proxy" (as defined in the Hylaws) signed by either spouse may cast the Home vote, when voting by Proxy is allowed, absent any prior written notice to the contrary to the Association by the other spouse or the designation of a different Proxy by the other spouse. In the event of prior written notice to the contrary to the Association or the designation of a different Proxy by the other spouse, the vote of said Home shall not be considered, but shall count for purposes of establishing a quorum.
- 1. A quorum shall consist of persons entitled to cast at least ten percent (10%) of the total number of votes of the Members.

ARTICLE VI TERM

The term for which this Association is to exist shall be perpetual. In the event of dissolution of the Association (unless same is reinstated), other than incident to a merger or consolidation, all of the assets of the Association shall be conveyed to a similar homeowners association or a public

agency having a similar purpose, or any Member may petition the appropriate circuit court of the State of Florida for the appointment of a receiver to manage the affairs of the dissolved Association and its properties in the place and stead of the dissolved Association and to make such provisions as may be necessary for the continued management of the affairs of the dissolved Association and its properties.

In no event shall the Association be dissolved, and any attempt to do so shall be ineffective, unless and until maintenance responsibility for the Surface Water or Stormwater Management System and discharge facilities located within the Property is assumed by an entity acceptable to the District, Florida Department of Environmental Regulation, or other governmental authority naving jurisdiction, pursuant to the requirements of Section 373.416(2), Florida Statutes and Chapter 62-330, Florida Administrative Code, or other administrative regulation of similar import, to the extent maintained by the Association and not the CDD. Further, such dissolution shall require the prior approval of the Army Corps of Engineers.

In the event and upon dissolution of the Association, if the Veterans Administration ("VA") is guaranteeing or the U.S. Department of Housing and Urban Development ("HUD") is insuring the mortgage on any Lot, then unless otherwise agreed to in writing by HUD or VA, any remaining real property of the Association shall be dedicated to an appropriate public agency to be used for purposes similar to those for which this Association was created. In the event that acceptance of such dedication is refused, such assets shall be granted, conveyed and assigned to any nemociate corporation, association, trust, or other organization to be devoted to such similar purposes. Such requirement shall not apply if VA is not guaranteeing and HUD is not insuring any manager; provided if either agency has granted project approval for Hadley Village, then HUD and VA shall be notified of such dissolution.

ARTICLE VII INCORPORATOR

The name and address of the Incorporator of these Articles is: Sandra F. Krumbein Sadov. Esquire, 200 East Broward Boulevard, Suite 2100, Fort Lauderdale, Florida 33301.

ARTICLE VIII OFFICERS

The affairs of the Association shall be managed by the President of the Association, assisted by the Vice President(s). Secretary and Treasurer, and, if any, by the Assistant Secretary(ies) and Assistant Treasurer(s), subject to the directions of the Board. Except for officers elected prior to the Turnover Date, officers must be Members, or the parents, children or spouses of Members.

The Board shall elect the President, Secretary and Treasurer, and as many Vice Presidents, Assistant Secretaries and Assistant Treasurers as the Board shall, from time to time, determine. The President shall be elected from amongst the membership of the Board, but no other officer need be a Director. The same person may hold two or more offices, the duties of which are not

incompatible; provided, however, the office of President and a Vice President shall not be held by the same person, nor shall the office of President and Secretary or Assistant Secretary be held by the same person.

ARTICLE IX FIRST OFFICERS

The names of the officers who are to serve until the first election of officers by the Board are as follows:

Vice President - Gary Brunk

Secretary/Treasurer - Mary Moulton

ARTICLE X BOARD OF DIRECTORS

A. The number of Directors on the first Board of Directors of the Association? First Board") and the "Initial Elected Board" (as hereinafter defined) shall be three (3). The number of Directors elected by the Members subsequent to the "Declarant's Resignation Event?" (as hereinafter defined) shall be not less than three (3) nor more than five (5), as the Hoard shall from time to time determine prior to each meeting at which Directors are to be elected. Except for Declarant-appointed Directors, Directors must be Members of the parents, children or spouses for officers or directors of Members. There shall be only one (1) vote for each Director.

B. The names and addresses of the persons who are to serve as Directors on the First Board are as follows:

Declarant reserves the right to replace and/or designate and elect successor Directors to serve on the First Board for so long as the First Board is to serve, as hereinafter provided.

- C. Declarant intends that Hadley Village, if and when ultimately developed, is anticipated to contain two hundred eighty-two (282) Lots with Homes constructed thereon (collectively, "Total Developed Lots"). Notwithstanding the foregoing, however, Declarant has reserved the right in the Declaration to modify the plan of development for Hadley Village and the right to, among other things, modify the site plan and the right to change the recreational facilities, if any, amonities, Home product types and the number of Homes to be constructed within Hadley Village) and/or the right to add or withdraw land from Hadley Village, all in its sole and absolute discretion, and therefore the total number of Homes with Hadley Village may refer to a number greater of lesser than two hundred eighty-two (282).
- D. Upon the Turnover Date, the Members other than Doclarant ("Purchaser Members") shall be entitled to circu not less than a majority of the Board. The election of not less than a majority of the Board by the Purchaser Members shall occur at a special meeting of the membership to be called by the Board for such purpose ("Initial Election Meeting"). The First Board shall serve until the Initial Election Meeting.
- E. The Initial Election Meeting shall be called by the Association, through the Board, within sixty (60) days after the Purchaser Members are entitled to elect a majority of Directors as provided in Paragraph D hereof. A notice of meeting shall be forwarded to all Members in accordance with the Bylaws; provided, however, that the Members shall be given at least fourteen (14) days prior notice of such meeting. The notice shall also specify the number of Directors which shall be elected by the Purchaser Members and the remaining number of Directors designated by Declarant.
- F. At the Initial Election Meeting, Purchaser Members, who shall include all Members other than Declarant, the number of which may change from time to time, shall elect two [2] [5] the Directors, and Declarant, until the Declarant's Resignation Event, shall be entitled to (the obligated to) designate one (1) Director (same constituting the "Initial Elected Board"). Declarant reserves and shall have the right until the Declarant's Resignation Event, to name the successor, if any, to any Director it has so designated.
- G. The Board shall continue to be so designated and elected, as described in Paragraph F above, at each subsequent "Annual Members' Meeting" (as defined in the Bylaws), until the Annual Members' Meeting following the Declarant's Resignation Event or until a Purchaser Member-elected Director is removed in the manner hereinafter provided.
- A Director (other than a Declarant-appointed Director) may be removed from office upon the affirmative vote of a majority of the voting interests of Members for any reason decided to be in the best interests of the Members. A meeting of the Purchaser Members to so remove a Director (other than a Declarant-appointed Director) shall be held upon the written request of ten percent (10%) of the Members.
- H. Upon the earlier to occur of the following events ("Declarant's Resignation Event"), Declarant shall cause all of its designated Directors to resign:

- 1. When Deciarant (and/or builders) no longer holds at least five percent (5%) of the Total Developed Lots for sale in the ordinary course of business and all Lots sold by Declarant (or builders) have been conveyed as evidenced by the recording of instruments of conveyance of such Lots amongst the Public Reports of the County; or
- 2. When Declarant causes the voluntary resignation of all of the Directors designated by Declarant and does not designate replacement Directors.

Upon Declarant's Resignation Event, the Directors elected by Parchaser Members shall elect a successor Director to fill the vacancy caused by the resignation or removal of Declarant's designated Director. This successor Director shall serve until the next Annual Members' Meeting and until his successor is elected and qualified. In the event Declarant's Resignation Event occurs prior to the Initial Election Meeting, the Initial Election Meeting shall be called in the manner set forth in Paragraph E of this Article X, and all of the Directors shall be elected by the Purchaser Members at such meeting.

- 1. At each Annual Members' Meeting held subsequent to Declarant's Resignation Event, all of the Directors shall be elected by the Members. At the first Annual Members Meeting held after the Initial Election Meeting, a "staggered" term of office of the Board shall be created as follows:
- 1. a number equal to fifty percent (50%) of the total number of Directors rounded to the nearest whole number is the number of Directors whose term of office shall be established at two (2) years and the Directors serving for a two (2) year term will be the Directors receiving the most votes at the meeting; and
 - 2. the remaining Directors' terms of office shall be established at one (1) yearn

At each Annual Members' Meeting thereafter, as many Directors of the Associations shall be elected as there are Directors whose regular term of office expires at such time, and the term of office of the Directors so elected shall be for two (2) years, expiring when their successors are duly elected and qualified.

J. The resignation of a Director who has been designated by Declarant or the resignation of an officer of the Association who has been elected by the First Board shall be deemed to temise, release, acquit, satisfy and forever discharge such officer or Director of and from any and all manner of action(s), cause(s) of action, suits, debts, dues, sums of money, accounts, reckonings, bonds, bills, specialties, covenants, contracts, controversies, agreements, premises, variances, trespasses, damages, judgments, executions, claims and demands whatsoever, in law or in equity, which the Association or Purchaser Members had, now have or will have or which any personal representative, successor, heir or assign of the Association or Purchaser Members hereafter can, shall or may have against said officer or Director for, upon or by reason of any matter, cause or thing whatsoever from the beginning of the world to the day of such resignation, except for such Director's or officer's willful misconduct or gross negligence.

ARTICLE XI INDEMNIFICATION

Each and every Director and officer of the Association shall be indemnified by the Association against all costs, expenses and liabilities, including attorney and paralegal fees at all trial and appellate levels and postjudgment proceedings, reasonably incurred by or imposed upon him or her in connection with any negotiation, proceeding, arbitration, litigation or settlement in which he or she becomes involved by reason of his or her being or having been a Director or officer of the Association, and the foregoing provision for indemnification shall apply whether or not such person is a Director or efficer at the time such cost, expense or liability is incurred. Notwithstanding the above, in the event of any such settlement, the indemnification provisions provided in this Article XI shall not be automatic and shall apply only when the Board approves such settlement and reimbursement for the costs and expenses of such settlement as being in the best interest of the Association, and in the event a Director or officer admits that he or she is or is adjudged guilty of willful misfeasance or mulfeasance in the performance of his or her duties, the indemnification provisions of this Article XI shall not apply. The foregoing right of indemnification provided in this Article XI shall be in addition to and not exclusive of any and all rights of indemnification to which a Director or officer of the Association may be entitled under statute or common law.

ARTICLE XII BYLAWS

The Bylaws shall be adopted by the First Board, and thereafter may be altered, anjunded or rescinded in the manner provided for in the Bylaws. In the event of any conflict between the provisions of these Articles and the provisions of the Bylaws, the provisions of these Articles shall control.

ARTICLE XIII AMENDMENTS

- A. Prior to the Pirst Conveyance, these Articles may be amended only by an instrument in writing signed by the Declarant and filed in the Office of the Secretary of State of the State of Florida.
- B. After the First Conveyance, and prior to the Turnover Date, these Articles may be amended solely by a majority vote of the Board, without the prior written consent of the Members, at a duty called meeting of the Board.
 - C. After the Tumover Date, these Articles may be amended in the following manner:
- 1. (a) The Board shall adopt a resolution setting forth the proposed amendment and directing that it be submitted to a vote at a meeting of the Members, which may be at either the Annual Members' Meeting or a special meeting. Any number of proposed amendments may be submitted to the Members and voted upon by them at one meeting.

- (b) Written notice setting forth the proposed amendment or a summary of the changes to be effected thereby shall be given to each Member within the time and in the manner provided in the Bylaws for the giving of notice of meetings.
- (c) At such meeting, a vote of the Members shall be taken on the proposed amendment(s). The proposed amendment(s) shall be adopted upon receiving the affirmative vote of a majority of the total voting interests present at such meeting.
- 2. An amendment may be adopted by a written statement (in lieu of a meeting) signed by all Members and all members of the Board setting forth their intention that an amendment to the Articles be adopted.
- D. These Articles may not be amended without the written consent of a majority of the members of the Board.
- E. Notwithstanding any provisions of this Article XIII to the contrary, these Articles shall not be amended in any manner which shall prejudice the rights of: (i) Declarant, without the prior written consent thereto by Declarant, for so long as Declarant holds either a leasehold interest in or title to at least one (1) Home or Lot; (ii) any "Institutional Mortgagee" (as such term is defined in the Declaration) without the prior written consent of such Institutional Mortgagee, or (iii) Participating Builders without the prior written consent of such Participating Builders.
- F. Notwithstanding the foregoing provisions of this Article XIII to the contrary, no amendment to these Articles shall be adopted which shall alridge, prejudice, amend or after the rights of Declarant or a Participating Builders without the prior written consent of Declarant or the Participating Builder, including, but not limited to, Declarant's right to designate and select members of the First Board or otherwise designate and select Directors as provided in Article X above, nor shall any other amendment he adopted or become effective without the prior written consent of Declarant for so long as Declarant holds either a leasehold interest in or title to at least one (1) Lot.
- G. Any instrument amending these Articles shall identify the particular article of articles being amended and shall provide a reasonable method to identify the amendment being made. A certified copy of each such amendment shall be attached to any certified copy of these Articles, and a copy of each amendment certified by the Secretary of State shall be recorded amongst the Public Records of the County.

ARTICLE XIV MERGERS AND CONSOLIDATIONS

Subject to the provisions of the Declaration applicable to the Property and to the extent permitted by law, the Association may participate in mergers and consolidations with other nonprofit corporations organized for the same purposes, provided that any such merger or consolidation shall be approved in the manner provided by Chapter 617, Florida Statutes, as the

same may be amended from time to time. For purposes of any vote of the Members required pursuant to said statutes, for so long as Declarant shall own any portion of the Property, any such merger or consolidation shall require Declarant's prior approval.
