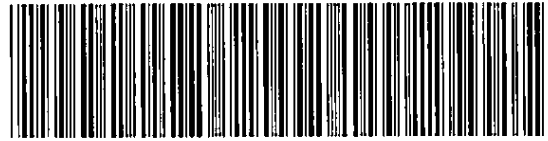

## ARTICLES OF INCORPORATION

In compliance with Chapter 617, F. S., (Not for Profit)

### **Article 1 Name:**

The name of the corporation shall be: EngAGING Seniors Corporation

### **ARTICLE II PRINCIPAL OFFICE:**

10605 SW Visconti Way Port St Lucie Florida 34986

### **ARTICLE III PURPOSE:**

The purpose for which the corporation is organized is: to empower seniors who need a little assistance, to continue to thrive in life. To connect active seniors, residential communities and volunteers with opportunities to give and volunteer for others who need a helping hand. To improve isolation, loneliness, and depression. To go beyond simply giving of goods, but to network and build relationships while working together...an elevated seniors helping seniors approach to life. Our senior population is growing quickly, especially in Florida and the number of those living alone is growing – depression is the silent killer. Enriching the lives of seniors is the focus of this non-profit. Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

### **ARTICLE IV MANNER OF ELECTION:**

After a 2-year appointment, there will be nomination requests with election for board members. Existing board members can be re-elected without nomination.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from

federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

If reference to federal law in articles of incorporation imposes a limitation that is invalid in your state, you may wish to substitute the following for the last sentence of the preceding paragraph:  
"Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation."


