ARTICLES OF INCORPORATION

OF

The Better Way Mentoring Legends, Inc.

A Non Profit Corporation

The undersigned, being over the age of eighteen (18) years and competent to contract, for the purpose of organizing a Corporation not-for-profit pursuant to the laws of the **State of Florida**, does hereby adopt the following Articles of Incorporation, and does hereby agree and certify as follows:

ARTICLE I

The name of this corporation is The Better Way Mentoring Legends, Inc.

ARTICLE II PRINCIPAL OFFICE

The physical and mailing address of the principal office of the Corporation shall be:

ARTICLE III PURPOSE AND POWERS

The primary purpose for which this Corporation is formed is to provide wrap-around services to underserved youth, adolescents, and young adults that will aid in lowering dropout rates and increase the number of of at risk graduates that pursue higher education.

- (1) The purpose for which the Corporation is organized and operated is exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(C)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. Such purposes shall include, but not be limited to the following:
 - (a) To provide at-risk youth, adolescents and young adults with services to encourage completion of high school and pursuit of higher education.
 - (b) To work with families of at-risk youth, adolescents, and young adults in order to avoid drop-out and assist with facilitating higher education opportunities.
 - (c) To provide one on mentoring and group mentoring services.
 - (d) To engage at risk youth, adolescents and young adults in activities to prepare them for adulthood
- (2) As a means of accomplishing the above purposes and methods, the Corporation shall have the following powers:
 - (a) To receive and accept gifts of money and property and to hold the same for any of the purposes of the Corporation and its work.
 - (b) To raise and assist in raising funds for the purposes herein set forth, including the issuance of bonds or other instruments of credits.
 - (c) To acquire, own, lease, mortgage and dispose of property both real and personals
 - (d) To accept property and donations in trust for religious or charitable purposes.
- (3) The property of the Corporation is irrevocable dedicated to religious, educational and charitable purposes, and no part of the net earnings of the corporation/organization shall foure to the benefit of, or be distributable to its members, trustees, directors, officers or other private persons, except that the corporation/organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of Section 501 (c)(3) purposes.
- (a) No substantial part of the activities of the corporation/organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation/organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of, or in opposition to, any candidate for public office.
- (b) The Corporation shall not:
 - (1) operate for the purpose of carrying on a trade or business for profit;
 - (2) accumulate income, invest income, or divert income, in a manner endangering its exempt status; or
 - (3) except to an insubstantial degree, engage in any activity or exercise any powers that are not in furtherance of the purposes of the Corporation.

ARTICLE IV MANNER OF ELECTION

Directors shall be elected as set forth in the Corporation's Bylaws.

ARTICLE V INITIAL BOARD OF DIRECTORS

This Corporation shall have three (3) directors initially. The number of directors <u>may be either</u> increased or <u>diminished</u> from time to time in accordance <u>with the Bylaws</u>, but shall never be less than three (3). - (2) by a corporation/organization, contributions to which are deductible under Section 170(c)(2) of the I.R.S. Code (or corresponding section of any future Federal tax code.)
- (3) Upon dissolution of this corporation/organization assets shall be distributed for one or more exempt purposes within the meaning of Section 501(C)(3) of the Internal Revenue Code, or corresponding section of any future Federal tax code, or shall be distributed to the Federal government, or to a state or local government, for a public purpose.

ARTICLE X AMENDMENT

This Corporation reserves the right to amend or repeal any provisions contained in these articles of incorporation, or any amendment hereto.
