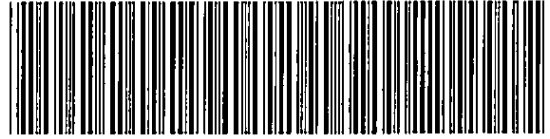

The specific purpose for which this corporation is organized is:

Exclusively for charitable, and educational purposes, including, for such purposes, the making of distributions to organization that qualify as exempt organizations described under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The organization promotes approximately four gatherings per year at locations dependent on

other organizations donating space, to bring together current military and retired aviation boatsains mates  
to discuss safety procedures, exchange information on safety protocols, engage in training classes, and  
attempt to further improve ship aviation safety. There are no fees charged to members and all expenses  
for activities are funded by donations. The directors spend about 20% of their time organizing the activities.


