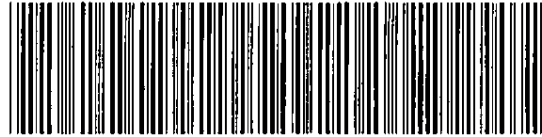

Unanimous vote for budget


*Joy Komoroski highlighted Women's Retreat and all women invited
