

# ARTICLES OF INCORPORATION FOR THE CAMPAIGN FOR THE AMERICAN FUTURE, \\ \( \cdot \) .

(A Florida Not For Profit Corporation)

# ARTICLE I NAME, PURPOSE AND STRUCTURE

- 1.1 <u>Legal Name</u>. The legal name of the corporation is Campaign Furthe American Future, lyc. (hereinafter referred to as the "Corporation").
  - 1.2 <u>Duration</u>. The period of the Corporation's duration is perpetual.
  - 1.3 Purpose.
  - 1.3.1 The Corporation is a social welfare organization as described in Internal Revenue Code (IRC) Section 502(c)(4) and may carry out any and all activities permitted to an organization exempt from federal income tax thereunder. The Corporation is a nonprofit corporation.
  - 1.3.2 Consistent with the foregoing, the Corporation exists for the express purpose of advancing the Christian religion, as described in the Corporation's Statement of Faith and other historic confessions consistent therewith, and including the beliefs of the Founding Fathers of the United States of America which the Corporation's founders believe to be derived therefrom.
  - 1.4 Priority. These Articles of Incorporation, adopted September 2, 2022 to take effect no later than April 12, 2023, replace and supersede any previously adopted and filed Articles of Incorporation, including but not limited to those filed with the Delaware Secretary of State on or about May 14, 2014.
  - 1.5 Structure. The Corporation shall have no capital stock. The conditions of membership in the Corporation and the manner in which Directors are elected shall be as stated in the corporate Bylaws.
  - 1.6 Restrictions. No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its Members, Directors, Officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth herein. Notwithstanding any other provision of these Articles, the Corporation shall not carry on any activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501(c)(4) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
