The corporation may, however, engage in activities that educate and inform the public on moral and biblical issues, provided such activities remain within the limitations allowed under Section 501(c)(3) of the Internal Revenue Code.*

*The corporation is committed to operating in a manner that reflects the teachings of Jesus Christ and will not engage in substantial lobbying or any activities that would jeopardize its tax-exempt status under federal law."*

These amendments were approved in accordance with Florida law and the governing documents of the corporation. The corporation has no members entitled to vote on the proposed amendments; therefore, the amendments were adopted by a majority vote of the board of directors on 20 March 2025.

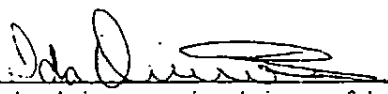
