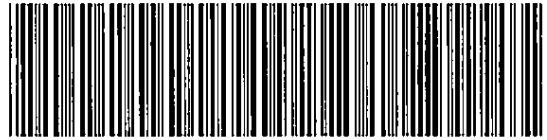

Pursuant to the provision of the Nonprofit Corporation Act of this state. The undersigned incorporators hereby adopt the following Articles of Incorporation:

ARTICLE I

The name of the corporation is **Jacob and Jewell Blanton Charitable Corporation.**

ARTICLE II

ARTICLE III

This corporation is organized and operated exclusively for charitable and educational purposes within the meaning of 501(c)(3) of the Internal Revenue Code.

The specific purposes for which this corporation is organized are to make distributions to other organizations that qualify as exempts organizations under Section 501(c)(3) of the Internal Revenue Code or as schools of public education.

No part of the net earnings of the corporation shall issue to the benefit of, or be distributed to its directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes described in section 501(c)(3). No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
