The undersigned incorporator hereby makes, subscribes, acknowledges and files with the Secretary of State of the State of Florida these Articles of Incorporation for the purpose of forming a Corporation not for profit in accordance with the laws of the State of Florida.

ARTICLES I: Name

The name of this Corporation shall be: Florida Rage Corp

ARTICLE II: Address

The physical and mailing address of the Corporation is 6952 Cucamelon Ct, Windermere, FL 34786

ARTICLE III: Purpose

The specific purpose of the corporation is exclusively for those charitable and educational, and to promote regional, national, or international amateur athletic competition, within the meaning of the 501(c)(3) Internal Revenue Code of 1984, as amended, including for purposes of providing gifts, donating, outreach programs, services and initiatives to individuals and organizations in need, for the promotion of public welfare through sports, health and education.

ARTICLE IV: Officers & Directors

The affairs of this Corporation shall be managed by a Board of Directors. The initial Officers and Directors compose of 3 members. The method of election of the officers and directors of the Corporation shall be provided for in the Bylaws of the Corporation. 
