

Additional purpose of Neulink, INC. a Florida non-profit corporation (hereinafter referred to as the "Corporation"), is to engage in activities exclusively for charitable, educational, religious, and scientific purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

To achieve its purpose, the Corporation shall:

- 1. Develop smart technology-based homes for individuals that meet the criteria for affordable housing while prioritizing families with disabled members in underserved communities.
- 2. Repurpose underutilized commercial spaces by leasing units to health and wellness groups, food resources, early intervention treatment centers, crime prevention programs, personal safety organizations, and community outreach programs in underserved neighborhoods under current market rates.
- 3. Neulink is determined to develop efficient mixed-use communities equipped with smart technology homes to assist families with disabled individuals. Our residents will live alongside other individuals with disabilities, civilian volunteers and health professionals. Every resident will benefit from the experience of living in our developments and this in turn promotes wellbeing and life satisfaction. The Neulink approach restores families, reduces stress at home, and expands social networks to strengthen resilience.

The Corporation shall not carry on any activities not permitted to be carried on by an organization exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Upon dissolution of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

This Purpose clause is intended to comply with the requirements of the Florida Not for Profit Corporation Act, and any future amendments thereto, as well as the regulations governing tax-exempt organizations.
