Attachment to Articles of Incorporation of 10-08 Forever Inc.

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under the section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The business activity for said organization is as follows: This non profit will serve to help those members of law enforcement involved with dispatching emergency services and corrections officers. We will help connect these individuals with resources to bridge the gap between their agencies. Member Assistance Programs and no help at all.
