## ARTICLES OF INCORPORATION OF KINGDOM WORSHIPPERS CHURCH INT'L MINISTRIES, INC. (A Not-For-Profit Corporation)

We the undersigned do hereby subscribe these Articles of Incorporation for the purpose of forming a corporation under laws of the Florida Statues, Section 617.0202 and subject to the following provisions.

### Article I

The name of the corporation shall be:

KINGDOM WORSHIPPERS CHURCH INT'L MINISTRIES, INC.

### Article II

### Section A.

The purpose of the corporation shall exist to effectively advance the principles and mandates of the gospel of Jesus Christ and the Kingdom of Heaven to a present day society. Our key purpose is to impact present and future generations through the ministry of reconciliation and restoration, as proclaimed in the holy scriptures; identifying the fact that ministry is God caring for His people where KINGDOM WORISHIPPERS CHRUCH INT'L MINITRIES has the spiritual advancement of (YOU), God's people at its center. Additionally, to facilitate transformative conferences, events and programs that will ultimately aid in empowering individuals and developing a solid family unit. Furthermore, to provide preschool and primary education facilities with a principal focus on advancing the cognitive skills of the youth. The corporation is organized exclusively for charitable, religious, educational and specific purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(C)3 of the Internal Revenue Code, or corresponding section of any future federal tax code. Lastly, to transacting any and all lawful business for which corporations may be incorporated. under the Florida Not-For-Profit Corporation Act.

### Section B.

No part of the net earnings of the organization shall incur to the benefit of, or be distributable to its directors, trustees, officers, or any other private individual (except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purpose set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign in behalf of any candidate for public office.

Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section of any future federal tax code, or (b) by organization contributions to which are deductible under section 170(c)2 of the Internal Revenue Code, or corresponding section of any future federal tax code.

#### Section C

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(C)3 of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state and local government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposed or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

### Article III

The corporation is a non-profit, non-stock corporation, and shall not have any memberships, or membership fees or admission fees.

### **Article IV**

The principal office of the corporation shall be located at:

### Article V

The corporation shall have (3) Director(s) initially. The number of director(s) may be increased or decreased from time to time in such a manner as may be prescribed by the By-Laws, but shall always be at least (3) one, but not more than (12) seven.

The corporation shall indemnify and hold harmless each person who shall serve at any time hereafter as a director or officer of the corporation, and serves at the request of the corporation, as a director or officer of any other corporation from against any and all claims and liabilities to which such person shall become subject by reason of his having heretofore or hereafter been a director or officer of this corporation, or by reason of any action alleged to have been heretofore or hereafter taken or omitted by him as such director or officer and shall reimburse each such person for all legal and other expense reasonably incurred by him in connection with any such claim or liability provided that no person shall indemnified against, or to be reimbursed for, any expense incurred in connection with any claim or liability as to which it shall be adjudged that such officer or director is liable for negligence or willful misconduct in the performance of his duties.

No contract or other transaction between this corporation and any other corporation, and no act of this corporation shall in any way be affected or invalidated by the fact that any of the directors of the corporation are peculiarly or otherwise interested in, or are directors, or officers, of such other corporation. Any director, individual, or any firm of which any otherwise interested in any contract or transaction of the corporation,

provided the fact that the interest should be disclosed or should have been known to the Board of Directors at which action upon such contract or transaction shall the corporation indemnify and hold harmless each person who shall serve any time hereafter as a director or officer of the corporation from against any and all claims and liabilities to which such person shall become subject by reason of his having heretofore or hereafter been a director or officer of this corporation, or by reason of any action alleged to have been heretofore or hereafter taken or omitted by him as such director or officer and shall reimburse each such person for all legal and other expense reasonably incurred by him in connection with any such claim or liability provided that no person shall indemnified against, or to be reimbursed for, any expense incurred in connection with any claim and liability as to which it shall be adjudge that such officer or director is liable for negligence or willful misconduct in the performance of his duties.

Any director, individual, or any firm of which any director may be a member, party to, or may be peculiarly or to otherwise interested in any contract or transaction of the corporation, provided the fact that the interest should be disclosed or should have been known to the Board of Directors at which action upon any such contract or transaction shall be taken, an any director of the corporation who is interested may be counted in determining the existence of a quorum at any meeting of the Board of Directors of the corporation which shall authorize such director or officer of such other corporation or not so interested.

Any action of such Board of Directors may be rescinded, or any officer or director removed from office, only upon a vote of the majority of the Board of Directors.

The private property of the officers and directors shall not be subject to the payment of the obligations of the corporation to any extent.

### Article X

The directors may at their discretion, repeal, alter, or amend the By-Laws of this corporation as provided under Chapter 607.081 of the Florida Statues, restricting the power vested in the Board of Directors to adopt, or repeal the By-Laws within its regular course of business.
