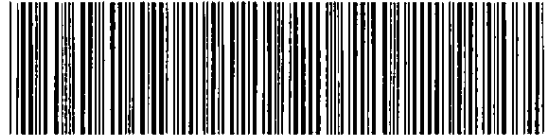

### Amendments Adopted

#### Article III. Purpose.
