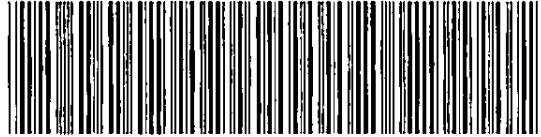

A. Change Article III to the following:

ARTICLE III
