

ATTACHMENT TO THE ARTICLES OF INCORPORATION OF VAAD HARABONIM FLORIDA – RABBINICAL ALLIANCE INC ARTICLE III: PURPOSE

H23000163892 3

Vaad HaRabonim Florida - Rabbinical Alliance Inc (hereafter: VRF/RAI) is established exclusively for Religious, Charitable and Educational purposes within the meaning of Internal Revenue Code, section 501(c)(3), namely: to strengthen, support and invigorate the existing Jewish infrastructures in the State of FL or elsewhere, by upholding the integrity and credibility of all matters pertaining to Yahadus (i.e. Jewish life). These matters include, but are not limited to: Kiddushin (Marriage) Gittin (Divorce) Kashrus (Food prepared according to Jewish Dietary Laws) Bris (Circumcision) Giur (Conversion to Judasim) Mikvaos (Ritual immersion pools), STAM (Sacred scrolls) and Batei Dinim (Rabbinical Courts.). VRF/RAI will strive to provide religious leadership to the Jewish communities of Florida; to supervise, and endorse Kosher food establishments; to establish and support existing institutions and schools for religious instruction; to provide rabbinical arbitration; to undertake communal, religious endeavors; to promote a spirit of brotherhood and a closer association between its members and between all the subdivisions they are assigned to: to assist in charitable work of any nature, that is deemed beneficial to the best interests of the corporation and of the society as a whole. VRF/RAI will raise funds for carrying the same into effect in any manner, allowed by the constitution and bylaws of the corporation, and permitted under the laws of the state of Florida and under Federal Law.

VRF/RAI will carry out any other activities or interventions which are seen by the directors as being in furtherance of the growth and thriving of Jewish life anywhere or everywhere, including, when necessary, the provision of charity to needy persons. families, communities or neighborhoods.

VRF/RAI will carry out all its activities according to Torah-Halachic tradition based on the Code of Jewish Law (Shulchan Aruch) by Shneur Zalman of Liadi and other authorized texts of traditional Judaism and customs, and according to all other lawful purposes which this corporation may undertake and maintain its status under the Internal Revenue Code Section 501(c)(3).

VRF/RAI will choose a recognized Rabbinic Authority to whom it will turn for instruction and guidance whenever necessary.

Upon the filing of these articles of incorporation with the Secretary of State, the Directors will be empowered to adopt bylaws and other related documents, to appoint corporate officers and to authorize them to open bank accounts, file forms with government agencies and undertake any other action required for the
