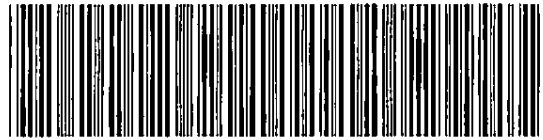

Pursuant to the provisions of section 617.1006, Florida Statutes, this Florida Not For Profit Corporation, FREDDI T. LANE EMPOWERMENT ALLIANCE, INC. (hereinafter the "Corporation"), desiring to amend its Articles of Incorporation, hereby adopts the following:

FIRST: The Corporation's Articles of Incorporation were filed with the Secretary of State of Florida on May 11, 2023, under Document Number N23000005815.

SECOND: Effective October 1, 2024 these First Amended Articles of Incorporation shall supersede the original Articles of Incorporation . To effect the foregoing, the Articles of Incorporation filed on May 11, 2023 are hereby amended as herein set forth:

The specific purpose for which this corporation is organized is:

The purpose for which this Corporation is formed, organized and operates is exclusively for charitable, religious, scientific, literary, and educational purposes, under section 501(C) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. Such purposes shall include the following:

1. To provide education, resources, services, and support for inclusive tourism.

2. To receive and accept financial aid (i.e. grants), donations and gifts (monetary and property), and receive fees for services as a means to accomplish the mission, purpose and activities of the Corporation.
3. To operate in all lawful activities which may be required, useful, or desirable for the accomplishments, or attainment of the foregoing purposes, either directly or indirectly, and either solely or in conjunction with other individuals, corporations, organizations, educational institutions, associations, trusts foundations, or government departments, or agencies.
4. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in any political campaign on behalf of, or in opposition to, any candidate for public office.




