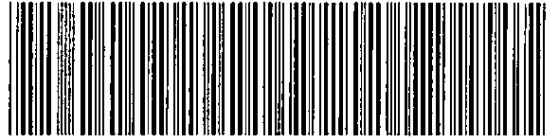

ARTICLE 5 - PURPOSE:
