WHEREAS, it is the intention of the Board of Directors of the Association that the Articles of Incorporation of the Association be amended, effective the date this Amendment is filed with the Florida Department of State, in accordance with the proposed amendment hereinafter set forth; and

WHEREAS, the proposed amendment to the Articles of Incorporation of the Association as hereinafter set forth was first approved by the required affirmative vote of a majority of the controlling membership interests of the Association on January 1, 2024 and thereafter by a majority vote of the Board of Directors of the Association pursuant to Article XIII, Section 2 of the Articles of Incorporation of the Association on January 1, 2024.

- 1. **<u>DIRECTORS</u>**. Section 6.1 of Article VI of the Articles of Incorporation of the Association are hereby amended and restated as follows:
- 6.1 Board of Administration: The affairs of the Association shall be managed by a Board of Administration consisting of a number of Directors determined by the By-Laws, but not less than three (3) Directors nor more than five (5) Directors; however, the Board shall consist of an odd number of Directors. Directors shall be members of the Association except as otherwise provided herein.
