

ARTICLE IX The corporation is organized in accordance with the Florida statutes 617.0202 as amended. The corporation has not been formed for the making of any profit, or personal financial gain. The assets of income of the corporation shall not be distributed to, or benefit the trustees, directors, or officers or other individuals. The assets and income should only be used to promote corporate purposes as describe beforehand. This corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax. The corporation shall not endorse, contribute to, work for, or otherwise support or oppose a candidate for public office. The corporation is organized exclusively for purposes subsequent to section 501(c)3 of the internal revenue code.

ARTICLE X Upon dissolution of the corporation all liabilities and obligations shall be paid, satisfied and discharged, or adequate provision shall be made therefor. Assets not held upon a condition requiring return, transfer, or conveyance to any other corporation or individual shall be distributed, transferred, or conveyed, in trust or otherwise, to charitable and educational corporations, organized under section 501(c)3 of the internal revenue code of 1986, as amended, of a similar or like nature to this corporation, as determined by the board of directors.
