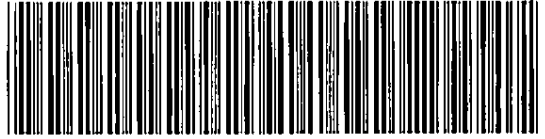

ARTICLES OF INCORPORATION
OF
MIAMI SHORES MENS GOLF ASSOCIATION, INC.

(Pursuant to 617, Florida Statutes (Not for Profit))

ARTICLE I
NAME

The name of the corporation shall be the Miami Shores Mens Golf Association, Inc. ("Company").

ARTICLE II
MAILING AND PRINCIPAL ADDRESS

The mailing and street address of the principal office of the Company shall be 1666 J.F. Kennedy Causeway, Suite 420, North Bay Village, Florida 33141.

ARTICLE III
PURPOSE

Company is organized exclusively for charitable, religious, educational, and scientific purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The business activity for the Company is, without limitation, the following:

- a. To promote friendly competition and good fellowship among amateur golfers.
- b. To conduct golf tournaments and competitions.
- c. And to advance the best interests of golfers in South Florida.

No part of the net earnings of this Company shall inure to the benefit of, or be distributable to, its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation services rendered and to make payments and distributions in furtherance of the purposes set forth in the Purpose clause hereof. No substantial part of the activities of the Company shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and this Company shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this statute, the Company shall not carry on any other activities not permitted to be carried on by an organization exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future tax code.






