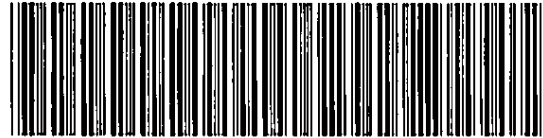



1. The current name of the Corporation is MISSION:ONTARGET, INC.
2. The date of the filing of the original Articles of Incorporation of the Corporation was May 22, 2023.
3. Article VI of the Corporation's Articles of Incorporation is hereby amended to read in its entirety as follows:
