<u>Premier Preschool Cares:</u> A Non-Profit Organization to help single parents with tuition and living necessities for children from 0-5 years of age.

<u>Purpose:</u> To help parents with preschool cost for children in their early years, (0-5); 80% of a child's brain development happens between 0 and 5 years old.

Rationale: As we ask parents to not abort children, it is very hard to survive as single parent when the baby is born. There is very little help after the baby is born for childcare. State institutions that can help parents with tuition for preschools are very difficult to navigate. The biggest problem is that those institutions have a lot of requirements, and the parents are placed on a waiting list. Meanwhile they cannot look for a job and it is very hard to resume normal life.

Also, quality preschools are very expensive, and most of them do not have any openings for low-income parents and even for parents that can pay.

The other problem is that there are many quality preschools that do not want to work with those institutions since the red tape is significant. The next concern is that quality preschools sign a contract with those institutions, and they pay a month later for the students' tuition, having a great impact on our businesses. The preschools are also overwhelmed with the amount of paperwork required by those programs. Consequently, very few quality preschool join those institutions and have a contract with them. Due to the great need for childcare for single parents, this non-profit organization would like to
