

Articles of Incorporation For Kharkiv Talents, Inc. as a Non Profit Corporation in the State of Florida

FIRST: The name of the Corporation is Kharkiv Talents. Inc.

SECOND: Its registered office and place of business in the State of Florida is to be located at 949 NW 18th Avenue, Boca Raton, FL 33486, County of Palm Beach. The registered agent in charge thereof is Registered Agent 4Less, Inc.

THIRD: The purpose of the Corporation is to engage in any lawful act or activity for which corporations may be organized under the general Corporation law of Florida. viz:

This corporation, also to be regarded for this purpose and known as a "foundation" is organized and operated exclusively as a non-profit organization that strives to promote business, education, and research in Kharkiv, Ukraine, making it a leading center for innovation and development. Kharkiv is an important city in Ukraine, and its rebuilding is crucial to the post-war reconstruction of the country. Kharkiv is rich in culture, education. and research, with a thriving high-tech industry and modern amenities. The city's young people are its greatest capital, and the foundation aims to create online educational programs that will provide them with opportunities to develop their skills and talents. Kharkiv is the new frontier for promoting Western values and is a kev partner for the United States in the region, The Kharkiv Ambassadors Foundation aims to strengthen the international relations of Kharkiv with US peers by promoting educational and scientific projects and cooperation. The foundation encourages research projects that promote innovation and advance the economic and social development of the region. Kharkiv is a city that embodies the values of freedom and democracy, and the foundation seeks to foster these values through its work. The Kharkiv Ambassadors Foundation serves as a bridge between the US donor and investors and the Kharkiv region. The foundation welcomes donations from individuals and institutions who share its vision of promoting research and education in Kharkiv.

By investing in the young people of Kharkiv and supporting their education and research projects, the foundation hopes to create a better future for the region and strengthen its ties with the United States within the meaning of $\S501(c)(3)$ of the Internal Revenue Code of 1986 (as amended) or the corresponding provision of any future United States internal revenue law, including for such purposes, the making of distributions to organizations which are recognized as exempt from tax under such $\S501(c)(3)$.

FOURTH: The Corporation shall not have any capital stock.

FIFTH: This is a directorship corporation and the sole members of the corporation are its board of directors, and all members of the board of directors are elected by the majority vote of its directors.

SIXTH: The name and address of the incorporator is as follows, viz: Nancy B. Stewart of 949 NW 18th Avenue, Boca Raton, FL 33486.

SEVENTH: No part of the net income or net assets of the corporation shall inure to the benefit of, or be distributable to, its directors, officers, members or other private persons. However, the corporation is authorized to pay reasonable compensation for services actually rendered and to make payments and distributions in furtherance of its tax-exempt purposes.

EIGHTH: The corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of any candidate for public office. No activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation.

NINTH: Upon the dissolution or winding up of the Corporation, all of the business, properties, assets and income of the Corporation remaining after payment, or provision for payment, of all debts and liabilities of this Corporation, shall be distributed to a nonprofit fund, association, or corporation which is organized and operated exclusively for tax exempt purposes which are reasonably related to the purposes and goals of this Corporation, as may be determined by the Board of Directors of this Corporation in its sole discretion, and which has established its tax exempt status under §501(c)(3) of the Internal Revenue Code of 1986, as amended.
