The undersigned, hereby certify that we have associated ourselves together for the purpose of forming a nonprofit corporation under the laws of the State of Florida pursuant to Fla. Stat. 617 entitled the Florida Corporation Act, providing for the formation, rights, privileges, and immunities of nonprofit corporations. We do hereby adopt the following Articles as the Charter and authority for the conduct of business of such nonprofit corporation.

ARTICLE I**NAME**

ARTICLE II**DURATION**

The period of this Company's duration shall be not more than 30 years, unless terminated by the unanimous written agreement of all members or by the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or upon the occurrence of any other event which terminates the continued membership of a member, unless the business of the Company is continued by the consent of all the remaining members, or by amendment of these Articles of NonProfit Corporation providing for the continued existence of the Company subsequent to the foregoing events.

ARTICLE III**PURPOSES AND POWERS**

The nature of the business or businesses to be transacted and which this nonprofit corporation is authorized to transact, in addition to those authorized by the laws of the State of Florida, and the powers of the nonprofit corporation, shall be as follows:

1. To engage in any nonprofit activity or business authorized under the Florida Statutes
2. In general, to carry on any and all incidental nonprofit business; to have and exercise all the powers conferred by the laws of the State of Florida, and to do any and all things herein set forth to the same extent as a natural person might or could do.
3. To purchase or otherwise acquire, undertake, carry on, improve, or develop, all or any of the nonprofit business, good will, rights, assets, and liabilities of any person, firm, association, or corporation carrying on any kind of business of a similar nature to that which this limited liability

company is authorized to carry on, pursuant to the provisions of the Articles; and to hold, utilize, and in any manner dispose of the rights and property so acquired.

4. To enter into and make all necessary contracts for its nonprofit business with any person, entity, partnership, association, corporation, domestic or foreign, or any domestic or foreign state, government, or governmental authority, or of any political or administrative subdivision, or department thereof, and to perform and carry out, assign, cancel, or rescind any of such contracts.

5. To exercise all or any of the nonprofit company powers, and to carry out all or any of the purposes, enumerated herein otherwise granted or permitted by law, while acting as agent, nominee, or attorney-in-fact for any persons or corporations, and perform and service under contract or otherwise for any corporation, joint stock company, association, partnership, firm, syndicate, individual, or other entity, and in such capacity or under such arrangement develop, improve, stabilize, strengthen, or extend the property and non for profit commercial interest thereof, and to aid, assist, or participate in any lawful enterprise in connection therewith or incidental to such agency, representation, or service, and to render any other service or assistance insofar as it lawfully may under the laws of the State of Florida, providing for the formation, rights, privileges, and immunities of not for profit companies.

6. To do everything necessary, proper, advisable, or convenient for the accomplishment of any of the purposes, or the attainment of any of the objects, or the furtherance of any of the powers herein set forth, either alone or in association with others incidental or pertaining to, or going our of, or connected with its business or powers, provided the same shall not be inconsistent with the laws of the State of Florida.

7. The several clauses in this statement of the general nature of the not for profit business or businesses to be transacted shall be construed as both purposes and powers of this company, and statements contained in each clause shall, except as otherwise expressed, be in no way limited or restricted by reference from the terms of any other clause. They shall be regarded as independent purposes and powers.

Nothing herein contained shall be deemed or construed as authorizing or permitting, or purporting to authorize or permit the company to carry on any business, exercise any power, or do any act which a company may not, under the laws of the State of Florida, lawfully carry on, exercise, or do.

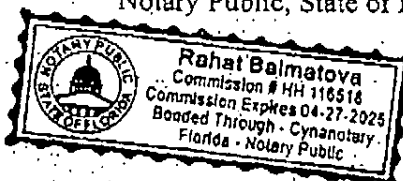
