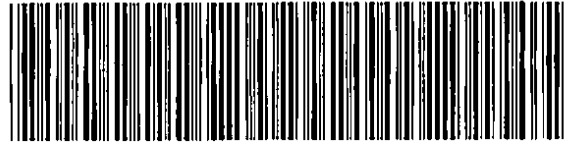

Articles of Incorporation

The undersigned, residents of the United States of America, desiring to form a non-profit organization under the Non-Profit Organization Laws of the State of Florida, do hereby certify:

Article I – Name of Organization

The name of the Organization shall be Fundacion Dejad A Los Ninos Venid a Mi y No Se Lo Impidais, Inc.

Article II – Principal Office and Mailing Address

The address of the principal office and mailing address of the Organization is 10317 NW Ninth Street Circle, Unit 401, Miami, Florida 33172.

Article III – Purpose of Organization

This Organization is organized and operated exclusively for charitable, religious, educational, and scientific purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1966 as now enacted or hereafter amended, including, for such purposes, the making of distributions to organizations that also qualify as Section 501(c)(3) organizations of the Internal Revenue Code of 1966 as now enacted or hereafter amended. Article VIII - Effective Date and Term of Existence

The effective date of the Organization is the date of approval by the Florida Department of State, Division of Corporations in 2023. The period of duration of this Organization is perpetual.

Article XIX -- Objectives

The objectives and purposes of this Organization are:

A. The purposes of the Organization are exclusively religious within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1966 or the corresponding provisions of any future United States Internal Revenue laws.

D. To carry on the business, businesses and all related activities, duties, acts and procedures connected with providing help for the needy, preaching, promotion and dissemination of the gospel message of Jesus Christ and the Bible as the inspired Word of God to man, based on our beliefs as Christians as Faith manual and moral behavior, to the end that the people of God may be conformed to the image of Jesus Christ through television, radio, Internet, different social media, newspapers and any other forms of mass communication and or conferences, meetings, study groups and any model or teaching strategy that helps the formation of disciples of Jesus through the establishment and management of Gospel missions, churches and other ministries, to be an Evangelical, Christian Ministry, with primary interests in evangelism and missionary work, involved in, and associated either directly or indirectly with, but not limited to, miscellaneous services, and other activities to be transacted with either foreign or domestic persons, firms, companies, Organizations, partnerships, governments or governmental agencies, and any other business or businesses, to the full extent permitted by the Laws of the State of Florida as a non-profit Organization.

Article X – Ministries

The ministries that this Organization will establish include, but are not limited to

A. To engage in, promulgate, foster, promote and otherwise cause to be accomplished the preaching, teaching and spreading of the Gospel, tenets, principles, concepts, admonitions, words, thoughts, projections, revelations and the whole embodiment of the Holy Bible, according to its

B. To engage in the ministry to man and mankind without limitation, which ministry shall include, but not limited to, the soul and spiritual aspect, the economic and social improvement, enhancement and well-being, the psychological aspect, the physical aspect, the intellectual aspect, and all other facets and areas of the life of man and mankind and/or the human being of all ages and in all areas for the purpose of improving and enhancing human life to the glory of God and for the human being's own enhancement, elevation and progress, including, but not limited, to vocational training.

C. To foster and promote the improvement and highest attainment in the areas of economic well-being, social relationships, intellectual achievements, physical improvement and spiritual development and growth for the purpose of enabling mankind of all ages and stations, regardless of the status of each individual, to form a more realistic attitude and approach to God as the Father and Creator of all things and the continuous improvement in the relationship of human beings among themselves. In the foregoing respects, it will not be the purpose of this Organization to promulgate secularistic, social and political concepts inasmuch as the purposes of the Organization are to promote relations with God as the Creator and Redeemer under the belief and principle that such relationship will then be reflected among all men for the enhancement and elevation thereof.

J. To establish a program to visit the prisons, with the main purpose of developing a prevention program inside the system, and to make the inmates aware of the AIDS epidemic, providing Bible classes, counseling and psychotherapy that could provide the emotional and spiritual support needed to help inmates cope with the system and prepare them to be model citizens when released.

K. M. To help the community in providing aid to female and male HIV patients and victims of domestic violence, giving them shelter, food, clothes, counseling, support groups, Bible

O. To help the children, preteens, teens, young, needing assistance for neglect, abuse, domestic violence, bullying, sexual abuse, sexual orientation, prevention of early pregnancy, orphans, parents died, learner problems, language problems, access to education at all levels, scholarships, access to sport, access to health, food, clothing, footwear, accommodation, counseling, providing the spiritual and psychosocial support, support groups, Bible classes, referrals to community/government helping children and teens.

P. Article XI - Enabling Powers

In order to provide any and all of the services set out above, the Organization shall have the power:

A. To apply for and obtain all such licenses and permits of whatever location needed as shall be deemed necessary for the lawful functions of the Organization.

B. To buy, sell or otherwise acquire, handle, hold and dispose of real and personal property or any interest therein; to enter into transactions of any kind or character whatsoever with respect to such real or personal and to dispose of it as may be required.

C. To manage, supervise, operate, control, lease, let and sublet offices, office buildings, and all other kinds and character of property of every nature whatsoever.

D. To purchase, or otherwise acquire, and to own and mortgage, pledge, sell, assign and transfer or otherwise dispose of, and to invent, trade, deal in and deal with goods, wares, merchandise and other personal property of every class and description whatsoever.

E. To buy, sell, manufacture, repair, alter and exchange, let or hire, export and deal in all kinds of articles and things which may be required for the purpose of any of the said businesses, or commonly supplied or dealt in by persons engaged in any such businesses, or which may seem as capable of being profitably dealt with in connection with any of the said businesses.

F. To guarantee, acquire by purchase, subscription or otherwise, hold for investment or otherwise, sell, assign, transfer, mortgage, pledge, or otherwise dispose of the shares of the capital stock of, or any bonds, securities or evidences of indebtedness created by any other Organization or Organizations of the State of Florida, or any other state or government, domestic or foreign; and while the owner of any such stocks, bonds, securities or evidences of indebtedness, to exercise all the rights, powers and privileges of ownership, including the right to vote thereon for any and all purposes; to aid by loan, subsidy guaranty, or in any other manner whatsoever so far as the same be permitted in the case of Organizations organized under the General Organization Laws of the State of Florida, any Organization whose stocks, bonds, securities or other obligations are or may be in any manner and at any time owned, held or

G. To acquire, hold, own, dispose of, and generally deal in grants, concessions, franchises and contracts of every kind; to cause to be formed, to promote and aid in any way in the formation of any Organization, domestic or foreign.

H. To act as financial, business and purchasing agent for domestic and foreign Organizations, individuals, partnerships, associations, state governments or other bodies.

I. To acquire in any manner, enjoy, utilize, hold, sell, assign, lease, mortgage or otherwise dispose of, letters patent of the United States or of any foreign country, patents, patent rights, licenses and privileges, inventions, improvements and processes, copyrights, trademarks and trade names or pending applications therefor, relating to or useful in connection with any business of the Organization or any other Organization in which the Organization may have an interest as a stockholder or otherwise.

J. To borrow money and contract debts when necessary for the transaction of its business or for the exercise of its corporate rights, privileges or franchises, or for any other lawful purpose of its incorporation; to issue bonds, promissory notes, bills of exchange, debentures and other obligations and evidences of indebtedness payable at a specified event or events, secured or unsecured, the right to convert the principal thereof into any preferred or common stock of the Organization, now or hereafter authorize, upon such terms and conditions as shall be fixed by the Board of Directors may deem judicious, subject, however, to the provisions of Article III hereof.

K. To acquire by purchase, subscriptions or otherwise, and to hold for investment, and to own, hold, sell, vote and handle shares of stock in other Organizations.

L. To have one or more offices, conduct its business and promote its objects within and without the State of Florida, in other states, the District of Columbia, the territories, possessions and dependencies of the United States, and in foreign countries, without restrictions as to place or amount.

In general, to do any or all of the things herein set forth to the same extent as natural persons might or could do and in any part of the world as principal agents, contractors, trustees, or otherwise, within or without the State of Florida, either alone or in company with others, and to carry on any other business in connection therewith, whether specifically stated herein or otherwise, and to do all things not forbidden, and with all the powers conferred upon nonprofit Organizations by the laws of the State of Florida.

It is the intention that each of the objects, purposes, and powers specified in each of the paragraphs of these Articles of Incorporation shall, except where otherwise specified, be nowise limited or restricted by reference to or inference from the terms of any other paragraph or any other articles or paragraphs of these Articles of Incorporation and shall be regarded as independent objects, purposes and powers, and the enumeration of specific purposes and powers shall not be constructed to restrict in any manner the general terms and powers of this Organization, nor shall the expression of one thing be deemed to exclude another, although it be of like nature. The enumeration of objects or purposes herein shall not be deemed to exclude or in any way limit by inference any powers, objects, or purposes which this Organization is empowered to exercise, whether hereafter in effect, or impliedly by any reasonable construction of said law. Article XII -- Capital Stock

This Organization is authorized to operate without stock as per the Laws of Florida.

Article XIII -- Beginning Capital

The amount of capital with which this Organization will be started has not been determined yet.

Article XIV -- Qualification of Membership

The categories of membership, qualifications for membership and the manner of admission shall be set forth and regulated by the By-Laws of the Organization.

Article XV - Voting Rights

The Organization shall have no voting members, the management and affairs of the Organization shall be at all times under the direction of the president and the Board of Directors, whose operations in governing the Organization shall be defined by statutes and the Organization's by-laws. No director shall have any right, title, or interest in or to any property of the Organization.

Article XVI- Educational Services

This Organization will engage in activities to provide educational services to children beginning with day care, elementary, middle, and high school and Bible school from children to adults.

Article XVII - Prohibition Against Private Inurement

No part of the net earnings of the Organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the Organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Three hereof. No substantial part of the activities of the Organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the Organization shall not carry on any other activities not permitted to be carried on (a) by a Organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a Organization, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article XVIII - Compensation

Resolved that any salaries, wages, together with fringe benefits or other forms of compensation (housing, transportation or other allowances) paid to or provided our employees, directors or officers will not exceed a value which is reasonable and commensurate with the duties and working hours associated with such employment and with the compensation ordinarily paid persons with similar positions or duties.

Article XIX – Limitation on Activities

No part of the net earnings of this Organization shall consist of carrying on propaganda, or otherwise attempting to influence legislation (except as otherwise provided by Section 501(h) of the Internal Revenue Code), and this Organization shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.

Notwithstanding any other provisions of these Articles, this Organization shall not carry on any other activities not permitted to be carried on (1) by a Organization exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or (2) by a Organization's contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

Article XX- Dissolution

In the event of dissolution of this Organization, its assets remaining after payment, or provision for payment, of all debts and liabilities of this Organization shall be distributed and turned over to one or more organizations which themselves are exempt as organizations described in Sections 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Code, or to the Federal, State or local government for exclusive public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the Organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

However, if the named recipient is not then in existence or no longer a qualified distribute, or unwilling or unable to accept the distribution, then the assets of this Organization shall be distributed to a fund, foundation or Organization organized and operated exclusively for the purpose specified in Section 501(c)(3) of the Internal Revenue Code (or corresponding section of any future Federal tax code).

Article XXI - Indemnification

The Organization shall indemnify a director or officer of the Organization who was wholly successful, on the merits or otherwise, in the defense of any proceeding to which the director or officer was a party because the director or officer of the Organization against any reasonable attorneys' fees and expenses incurred by the director or officer in connection with the proceeding. The Organization may indemnify an individual made a party to a proceeding because the individual is or was a director, officer, employee or agent of the Organization against liability if authorized in the specific case after determination, in the manner required by the Board of Directors, that indemnification of the director, officer, employee or agent, as the case may be, is permissible in the circumstances because the director, officer, employee or agent has met the standard of conduct set forth by the Board of Directors. The indemnification and advancement of attorneys' fees and expenses for directors, officers, employees, and agents of the Organization shall apply when each person is serving at the Organization's request whether as a director, officer, employee or agent of another foreign or domestic Organization, partnership, joint venture, trust, employee benefit plan or other enterprise, whether or not for profit, as well in their official capacity with the Organization. The Organization also may pay for or reimburse the reasonable attorneys' fees and expenses incurred by a director, officer, employee, or agent of the Organization who is a party to a proceeding in advance of final disposition of the proceeding.

The Organization also may purchase and maintain insurance on behalf of an individual arising from the individual's status as a director, officer, employee, or agent of the Organization, whether or not the Organization would have power to indemnify the individual against the same liability under the law. All references in these Articles of Incorporation are deemed to include any amendment or successor thereto. Nothing contained in these Articles of Incorporation shall limit or preclude the exercise of any right relating to indemnification or advance of attorneys' fees and expenses to any person who is or was a director, officer, employee or agent of the Organization or the ability of the Organization otherwise to indemnify or advance expenses to any such person by contract or in any other manner. If any word, clause or sentence of the foregoing provisions regarding indemnification or advancement of attorneys' fees or expenses shall be held invalid as contrary to law or public policy, it shall be severable and the provisions remaining shall not be otherwise affected. All references in these Articles of Incorporation to "director," "officer," "employee," or "agent" shall include their heirs, estates, executors, administrators and personal representatives of such persons.

Article XXII – Liabilities for Debts

The members, officers, directors, employees, or agents of the Organization shall be liable for the debts of the Organization.

Article XXIII – Amendments

These Articles of Incorporation may be amended in the manner provided By Law. Every amendment shall be approved by the Board of Director proposed by them to the Members and approved at a Members meeting by a majority of the Members, unless all the Directors and all the Members sign a written statement manifesting their intention that a certain amendment of these Articles of Incorporation be made.

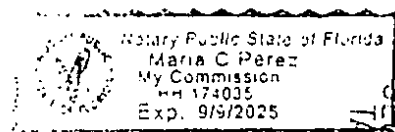


