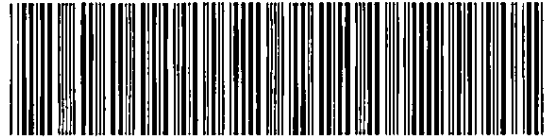

of any future federal tax code.


