This corporation is founded exclusively for charitable religious purposes within the meaning of the IRS Code Sec 501(c)(3), namely: To establish and maintain a Center for Jewish spirituality and religion and there to provide Jewish religious, educational, cultural, social and all other helpful services to the Jewish community in South Florida and elsewhere. These services will include, but not be limited to: religious events, services. religious education classes, spiritual guidance, community outreach, inspirational events, celebrations, sacred feasts, retreats, excursions, cultural or social activities, as well as all manner of helpful services to the Jewish community. It will work to reach out to unaffiliated Jewish persons and to all who seek Judaism's universal path for humanity. It will foster a vibrant community of persons and families who are growing in their awareness of G-d's presence in the world and in their understandings of the teachings of Orthodox Judaism in both their revealed and inner dimensions. It will promote and strengthen Jewish awareness, pride and unity through educational, cultural and social activities for all Jewish persons and families in the area regardless of background or affiliation. It will likewise strive to prepare rectify the world by bringing all persons in the general community closer to The Creator in the ways that are right for each.

This corporation will carry out its activities according to Torah-Halachic tradition contained in the Code of Jewish Law (Shulchan Aruch), by Rabbis Yosef Karo and Moshe Isserles, as well as in the subsequent commentaries or responsa and in the mystical texts of Judaism, all as understood by the synagogue's Rabbi, who is incorporator of this corporation, Jacob Stefansky.

This corporation will be empowered to pay salaries or wages, as well as to rent or buy personal or real property, in order to carry out its activities, and provide a place of worship as well as a parsonage for the Rabbi and his family. The Rabbi has been appointed according to Jewish Religious Law. He is the spiritual head of the organization and the final authority in all matters pertaining to Ethics, Spirituality and Religious Law, including the sole right to determine which issues should be regarded as matters of Ethics, Spirituality and Religious Law, thus requiring his decision.

This corporation shall not, except in an insubstantial way, engage in any activities or exercise any powers that are not in furtherance of its charitable religious purposes. It will not attempt to influence legislation in any way or participate in political campaigns of any sort. No part of the net earnings of this corporation shall inure to the benefit of, or be distributable to its directors, officers or any private person except that this

corporation will be empowered to pay reasonable compensation for work done, services rendered, resources purchased or properties acquired that are required for furtherance of its exempt purposes.

This corporation is empowered to supply all the foods, religious items and physical constructions or properties required according to Jewish Law and the mystical traditions, including but not limited to: Religious Articles, Kosher Food, Ritual Immersion Pools, or transportation to any event or location which in the view of the Rabbi or Directors is required for the fulfillment of Religious Duties as understood in Jewish Tradition.

Upon the filing of these articles of incorporation with the Secretary of State, the Directors will be empowered to adopt bylaws and other related documents, to appoint corporate officers and to authorize them to open bank accounts, file forms with government agencies and undertake any other action required for the operation of this corporation. The directors will adopt such decisions through in person meetings, telephonic communication, meetings via electronic media, written and signed consent, as well as by virtual signatures. Replies sent from emails belonging to directors or messages via any form of electronic communication belonging to directors, shall be seen as written signed consent and the equivalent of a vote cast at a meeting of the directors.

Upon the dissolution of this corporation, the directors will --after dearing all debts and liabilities-- distribute all remaining assets to one of more organizations with similar exempt purposes recognized under section 501(c) (3) of the IRS Code.
