**ARTICLES OF INCORPORATION OF  
POPSTROKE CARES FOUNDATION, INC.  
(a Florida Not-for-Profit Corporation)**

The undersigned, being citizens of the United States, for the purpose of forming a not-for-profit corporation under the Florida Not-For-Profit Corporation Act, Florida Statutes Chapter 617, makes and adopts the following articles of incorporation:

ARTICLE I      NAME

The name of the corporation shall be: **Popstroke Cares Foundation, Inc.**

ARTICLE II      PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

1001 N. U.S. Highway One, Suite 500, Jupiter, Florida 33477

ARTICLE III      PURPOSE

This corporation is organized and shall be operated exclusively for charitable, scientific, and educational purposes under section 501(c)(3) of the Internal Revenue Code ("Code Section"), or the corresponding section of any future federal tax code, including but not limited to making distributions to organizations that qualify as exempt organizations under the provisions of said Code Section. This corporation shall be a not-for-profit corporation.

ARTICLE IV      MANNER OF ELECTION

The manner in which the Directors of this corporation are elected or appointed shall be as stated in the By-Laws.

ARTICLE V      INITIAL DIRECTORS AND OFFICERS

The affairs of this corporation shall be managed by a Board of Directors. The initial number and minimum number of Directors shall be three. The number of Directors may be increased or decreased from time to time as set forth in the By-Laws of this corporation. Any director may be removed by an affirmative vote of at least two-thirds of the Board of Directors. ARTICLE VIII MEMBERSHIP

This Corporation shall have no members and shall not issue shares of stock.

ARTICLE IX DURATION

The duration of this corporation shall be perpetual.

ARTICLE X LIMITATIONS

No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation (except as otherwise provided by Section 501 (b) of the Internal Revenue Code), and this corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.

No part of the net earnings of this corporation shall inure to the benefit of, or be distributable to, its members, directors, officers, or other private persons, except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these articles.

Notwithstanding any other provision of these articles, this corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

All references to sections of the Internal Revenue Code shall include such sections as of the date hereof and the corresponding section of any future federal tax code.

ARTICLE X1 DISSOLUTION

On dissolution of the corporation, the Board of Directors shall, after paying or making provisions for the payment of all of the liabilities of the corporation, distribute all of the assets of the corporation exclusively for charitable, scientific, or educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code in such manner and to such qualified organizations as the Board of Directors shall determine. Any assets not so disposed shall be distributed to the federal government, or to the state or local government for a public purpose, or in accordance with the directions of a court having jurisdiction in the county where the principal office of this corporation is located, exclusively for the purposes of this corporation or to a qualified organization or organizations as the court shall determine.
