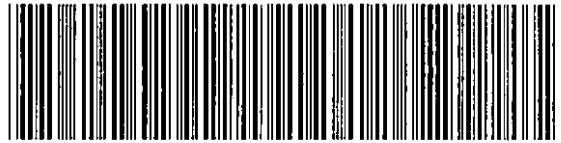

ARTICLES OF INCORPORATION FOR  
THE FOSTER CARE SUPPORT FOUNDATION, INC.  
A TAX-EXEMPT FLORIDA CORPORATION

ARTICLE I

The undersigned, being at least eighteen years of age, hereby forms a not for profit corporation under the laws of the State of Florida.

ARTICLE II

The name of the corporation is THE FOSTER CARE SUPPORT FOUNDATION, INC. and it is hereafter referred to as the "Corporation".

ARTICLE III

The Corporation is organized intending to be a Private Operating Foundation exclusively for charitable, educational, and scientific purposes, including, for such purposes, the making of distributions to individuals who are, or have been, within the Florida Foster Care system. The foregoing purposes include, but are not limited to, the following:

- (i) Provide financial assistance to families who are in the Florida foster care system to allow them to have normal living conditions after taking into account all income and benefits.
- (ii) Provide financial assistance and advice to individuals who are, or who have been, foster children to help provide them opportunities which are not financed by the State.
- (iii) Make day care available so that foster parents can have full time jobs to support their families.
- (iv) Provide advice to foster parents as to benefits which may be available to them and their foster children.

ARTICLE IV

The street address of the principal place of business and the mailing address of the Corporation in Florida is 50 Leannai Way, Suite C2, Palm Coast, Florida 32137.

ARTICLE V

The name of the resident agent of the corporation in Florida is James Morelewicz whose address is 46 Jasmine Drive, Palm Coast, Florida 32137.

#### ARTICLE VI

The Corporation shall have Members whose eligibility to become Members and whose rights and obligations as Members shall be set forth in the By-Laws. No Member shall be responsible for any of the obligations of the Corporation without his or her express written consent.

#### ARTICLE VII

The number of directors of the corporation shall be THREE (3) which number may be increased or decreased pursuant to the bylaws of the corporation. The initial Board of Directors shall be appointed by the incorporator of the Corporation. Thereafter, Directors of the Corporation shall be elected by the Members in the manner set forth in the By-Laws of the Corporation.

#### ARTICLE VIII

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to, its members, trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

#### ARTICLE IX

Upon the dissolution of the Corporation, its assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to a local government for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.


