

ARTICLES OF INCORPORATION OF SUPER SPINES, INC.

The undersigned incorporator to these Articles of Incorporation is a natural person competent to contract and hereby forms a Corporation not for profit under Chapter 617 of the Florida Statutes.

ARTICLE I - NAME

The name of the Corporation is SUPER SPINES, INC., (hereinafter, "Corporation").

<u>ARTICLE II - PURPOSE</u>

The specific purpose for which this Corporation is organized is to support pediatric spinal fusion surgery patients through, including without limitation, the provision of supplies and care packages. The general nature, objectives, and purposes for which this Corporation is organized and operated are to receive and administer funds for charitable, religious, educational, scientific, literary, and testing for public safety purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended. This Corporation shall receive and maintain funds of real and/or personal property, and subject to the restrictions and limitations hereinabove and hereinafter set forth, shall use the whole or any part of the income therefrom and the principal thereof exclusively for its charitable, scientific, literary or educational purposes.

ARTICLE IX - PROHIBITED ACTIVITIES

No part of the net earnings of the Corporation shall inure to the benefit of or be distributable to any member, director or officer of the Corporation, or any private individual (except that reasonable compensation may be paid for services rendered to or for the Corporation affecting one or more of its purposes), and no member, director or officer of the Corporation, or any private individual shall be entitled to share in the distribution of any of the corporate assets on dissolution of the Corporation. No substantial part of the activities of the Corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation and the Corporation shall not participate in, or intervene in (including the publication or distribution of statements), any political campaign on behalf of any candidate for public office.

Notwithstanding any other provisions of these Articles of Incorporation, the Corporation shall not conduct or earry on any activities not permitted to be conducted or carried on by an organization exempt under Section 501(c)(3) of the Internal Revenue Code or the regulations issued thereunder, or by an organization, contributions to which are deductible under Section 170(c)(2) of such Code and regulations issued thereunder.

ARTICLE X - DISTRIBUTIONS UPON DISSOLUTION
