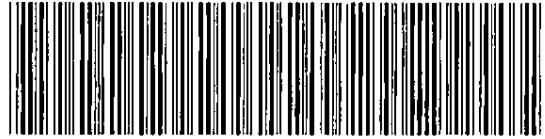

(Not for Profit)
OF
FOR ALL THE RIGHT REASONS, INC.**

Article I – Name

The name of the Corporation shall be For All The Right Reasons, Inc.

Article II – Address of Corporation

The principal address of the Corporation and the mailing address shall be:

Article III - Purpose

The specific purpose for which this Corporation is organized is to aid and support police forces, law enforcement personnel, and first responders through a number of activities as described herein. In order to advance its mission as described in these Articles, the Corporation will help provide equipment to underfunded police departments; the Corporation will endeavor to provide psychological, emotional and financial assistance to wounded officers, or officers who have suffered a traumatic event and/or who may have suffered from PTSD related symptoms; the Corporation will help the families of fallen officers through financial assistance, as well as emotional and psychological assistance; the Corporation will seek to provide scholarships and monetary support to the children of fallen officers.

The Corporation is organized exclusively for charitable, religious, educational, and scientific purposes under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Upon the dissolution or winding up of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

Article IV – Manner of Election

The manner in which the directors are to be elected or appointed shall be as stated in the bylaws of the Corporation.




