Articles of Incorporation

Article I Corporate Name

The name of the corporation shall be:

Karuna Care Association, Inc.

Article II Principal Office

The corporation's principal place of business and mailing address shall be:

530 W University Avenue, Suite 113 Gainesville, Florida 32601

Article III Organization

Karuna Care Association, Inc. is organized to provide introductory-level training for persons of faith who wish to enhance their interpersonal awareness and skills to become a compassionate presence in the lives of others.

The corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(e)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article IV Election of Directors

Directors shall be elected and serve for terms as provided in the corporation's by-laws.

Article V Members

Regardless of nomenclature, the corporation shall have no voting members. All matters pertaining to corporate governance shall be reserved to the Directors.

Article VII Corporate Existence

The duration of the corporation shall be perpetual.

Article VIII Limitations on Corporate Powers

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the exempt purposes set forth in these Articles of Incorporation.

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, the corporation shall not carry on any activity not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c) (2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article IX **Dedication and Distribution of Assets**

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. Such assets shall be distributed to the International Vaishnava Seminary Inc., FEIN 88-4245923. If said International Vaishnava Seminary Inc. is ineligible to receive such assets, the assets shall be distributed to The Institute for Vaishnava Studies Inc., FEIN 95-4586162. Any assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
