ARTICLES OF INCORPORATION OF NEW HOPE CEMETERY MARIANNA CUSTODIAN, INC. A FLORIDA NOT FOR PROFIT CORPORATION

The undersigned subscriber to these Articles of Incorporation, being a natural person, competent to contract, hereby forms this corporation under the laws of the State of Florida.

ARTICLE I NAME

The name of this Florida Not for Profit Corporation is NEW HOPE CEMETERY MARIANNA CUSTODIAN, INC.

ARTICLE II

GENERAL AND SPECIFIC PURPOSES

- (a) The specific and primary purposes of which this corporation is formed are to:
 - (i) To assure the perpetuation, maintenance and beautification of the New Hope Cemetery in Marianna, Florida.
 - (ii) To promote hearty cooperation in our service and gifts in the upkeep of the cemetery.
 - (iii) To promote the systematic maintenance and development of the New Hope Cemetery in Marianna, Florida and its improvements.

ARTICLE III TERM OF EXISTENCE

This corporation is to exist perpetually.

ARTICLE IV MEMBERSHIP

The corporation shall have a membership as provided in the By-Laws.

ARTICLE XI AMENDMENT TO ARTICLES

Amendments to the articles of incorporation may be proposed by the Board of Directors and shall be adopted by action of the majority vote of the directors of the New Hope Cemetery Marianna Custodian, Inc. present at any meeting of the directors; provided, however, that no amendment shall authorize the corporation or its directors to conduct the affairs of the corporation in any manner or for any purpose contrary to the provision of Section 501 (c)(13) of the Internal Revenue Code and any regulations promulgated there under. Any such amendment to these Articles of Incorporation shall be made only in accordance with the laws of the State of Florida.
