The corporation does indemnify and directors, officers, employees, incorporators, and members of the corporation from any liability regarding the corporation and the affairs of the corporation, unless the person fraudulently and intentionally violated the laws and/or maliciously conducted acts to damage and/or defraud the corporation, or as otherwise provided under applicable statue.

The purpose of the corporation is exclusively for charitable, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the internal revenue code, or the corresponding section of any future federal tax code and herein stated as follows:

The purpose for which the corporation is formed is: That's a Wrap- a charity created to provide funds to Ukrainian families and individuals in order to return or relocate home when the war wraps up. Home may be a rental in a new town, a newly rehabbed home or families may be fortunate to go back to their homes with assistance. Small amounts of monies will be provided for relocation and rehoming expenses. That's a Wrap will closely and carefully distribute collected money. We will work (most likely) with Global Volunteers translator and may collaborate with Global Volunteer executives in determining best distribution of funds.

The character and essence of the corporation is the same as the purpose.

No parts of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth. Article 11. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any-political campaign on behalf of or in the opposition of any candidate for public office. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree engage in any activities or exercises any powers that are not in furtherance of the purposes of this corporation.

Upon the dissolution of the corporation, after paying or making provisions for the payment of all the legal liabilities of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine which are organized and operated exclusively for such purpose.
