# Articles of Amendment to Articles of Incorporation of Javelin Landing Owners Association, Inc.

 The following language, indicated by a strike-through, is deleted from Article IV of the Articles of Incorporation of Javelin Landing Owners Association, Inc.:

# ARTICLE IV PURPOSE(S)

To levy and collect adequate assessments against Members of the Association for the costs of maintenance and operation of a portion of the Stormwater Management System in accordance with the Declaration. The assessments shall be used for the maintenance and repair of the Stormwater Management System and mitigation or preservation areas, including but not limited to work within retention areas, drainage structures and drainage easements.

 The following language, indicated by a strike-through, is deleted from Article V of the Articles of Incorporation of Javelin Landing Owners Association, Inc.:



#### ARTICLE V GENERAL POWERS

12. To operate and maintain that portion of the Surface Water Stormwater Management System located on Lots and designated in the Plat of Subdivision as Private Drainage/Access Easements, including all inlets, ditches, swales, culverts, water-control structures, retention and detention areas, ponds, lukes, floodplains compensation areas, wetlands and any associated buffers and wetland-mitigation-areas, preserve areas and conservation easements, as applicable and required by the Permit, and to contract for services to provide for such operation and maintenance, with the power to accept future phases into the Association that will utilize the Surface Water Management System.

All other provisions of the Articles of Incorporation of Javelin Landing Owners Association, Inc. remain in effect.
