ARTICLES OF INCORPORATION
OF
Central Florida Indian Community Inc

[In compliance with Chapter 617, F.S., (Not for Profit)]

ARTICLE I: The name of the Corporation shall be:

Central Florida Indian Community Inc

ARTICLE II: The principal place of business and mailing address shall be:

628 Pickfair Ter, Lake Mary, FL 32746

ARTICLE III: The purpose for which the Corporation is organized is to promote and implement the "Help Each Other" concept of Indian origin through events, and conferences especially in Central Florida and other regions of the USA. To raise, solicit, and collect funds and donations either directly or in cooperation with other not for profit organizations for the goal and charitable purposes in Central Florida and other regions of the USA.

ARTICLE IV: IRS Clause:

(a) The corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations as specified under Section 501(c)(3) of the Internal Revenue Code of 1954, and shall not carry on any activities not permitted to be carried on by a corporation exempt from Federal income tax under Internal Revenue Code Section 501(c)(3) or corresponding provisions of any subsequent Federal tax laws or by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Revenue Law).

(b) No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth hereof.

(c) Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which

the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

(d) No substantial part of the activities of the corporation shall be carrying on of propaganda, or otherwise attempting to influence legislation and the corporation shall not participate in or intervene in (including the publication or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

(e) In any taxable year in which the corporation is a private foundation as described in IRC Sec 509, the corporation shall distribute its income for said period at such time and manner as not to subject it to tax under IRC Sec 4942, and the corporation shall not engage in any act of self-dealing as defined in IRC Sec 4941(d), retain any excess business holdings as defined in IRC Sec 4943(c), make any investments in a manner as to subject the corporation to tax under IRC Sec 4944, or make any taxable expenditures as defined in IRC Sec 4945(d) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE V: The manner in which the directors are appointed will be set forth in the Bylaws.
